Engrossed House Bill 1967 adds a section to RCW 43.43 stating that upon a guilty plea or conviction for Driving Under the Influence (DUI) the prosecuting attorney shall notify the State Patrol of such plea or conviction. In turn the State Patrol will notify the Department of Health that a person has pled guilty to or been convicted of a DUI violation. The DOH will identify whether the person holds a credential issued by the medical quality assurance commission, and would then assess whether or not the physician should be referred to the impaired physician program.

The WSP currently sends some conviction data to DOH on a quarterly basis. The list of DUI convictions could be added to this list. A memo of understanding would be drafted between the WSP and DOH to provide details of which violations would be provided

Section 1: This bill provides a method to report medical physician conviction for driving while under the influence (DUI) to the Department of Health (DOH), Medical Quality Assurance Commission.

Revenue will need to be developed through fee increases to offset expenditures. Depending on the impact of this bill and other new legislation that may also impact program expenditures, an exception to I-601 may be required.

Section 1: This bill requires the prosecuting attorney to notify the Washington State Patrol (WSP) on DUI guilty pleas or convictions of medical physicians. The WSP is required to send the information to DOH. The DOH, Office of Health Professions Quality Assurance (HPQA) will verify if the individual is a licensed medical physician and report to the Medical Quality Assurance Commission to review and assess if the physician should be referred to the impaired physician program.

HPQA currently receives felony information from the WSP. This bill will expand the WSP reporting requirements to include DUI convictions. HPQA will need to screen the information against medical licensee records. An investigation will be required for those physicians identified as currently licensed by HPQA and convicted of a DUI.

For purposes of this fiscal note, HPQA is assuming that approximately 50 physicians will have DUI convictions each year. This estimate is based on the number of other convictions that medical physicians have and assume they will have the same rate for DUIs.

Starting in FY 2008, and ongoing, HPQA is estimating receiving an additional 50 cases for investigation on medical physician license holders each year. Costs will include staff and associated costs, Office of Attorney General time, printing and postage. Staff includes 0.29 FTE Health Care Investigator 2, 0.04 FTE Health Care Investigator 4, 0.15 FTE Hearings Examiner 3 (Staff Attorney), 0.02 FTE Senior Staff Attorney (WMS, Band 2), 0.06 FTE Legal Secretary 2, 0.01 FTE Legal Secretary 1, 0.01 FTE Legal Secretary 3, 0.01 FTE Office Assistant 3, 0.03 FTE Paralegal 2, 0.04 FTE Hearings Examiner 3 (Health Law Judge), and 0.02 FTE Hearing Scheduler. Total staff equates to 0.68 FTE.

There will also be salary, benefit, and associated costs with administrative workload. Starting in FY 2008, staff will include a 0.10 FTE Health Services Consultant 2 and a 0.10 FTE Financial Analyst 2. These costs will be ongoing.

Part IV: Analysis

A. SUMMARY OF BILL

Provide a clear, succinct description of the bill with an emphasis on how it impacts local government.

This bill will create a new avenue of communication from the prosecuting attorney to the Washington State Patrol (WSP), to the Department of Health (DOH) to the medical quality assurance commission.

Section 1 mandates that the prosecuting attorney in each county notify the WSP of all guilty pleas and convictions for "Driving Under the Influence" and "Physical Control of Vehicle Under the Influence."

B. SUMMARY OF EXPENDITURE IMPACTS

Briefly describe and quantify the expenditure impacts of the legislation on local governments, identifying the expenditure provisions by section number, and when appropriate, the detail of expenditures. Delineate between city, county and special district impacts.

This bill creates a path for communication of information for all guilty pleas and convictions for "Driving Under the Influence" (DUI) and "Physical Control of Vehicle Under the Influence" from the prosecuting attorney to notify the WSP, from WSP to DOH, and for DOH to determine whether any physicians need to be examined by the medical quality assurance commission.

SECTIONS OF THE BILL WITH LOCAL FISCAL IMPACT:

FIRST-YEAR COSTS -- It will be necessary to create a new relationship between municipal courts and prosecuting attorney offices in each courthouse. There are 127 municipal courts that will need to deliver information to the 39 county prosecutor's offices. Assuming a week's time for staff to work out the details and create interlocal agreements for the transfer of data for each of the 127 courts, there would be a requirement for 5,080 hours of staff time in the first year. This equates to 2.45 FTE, if each FTE costs approximately \$46,000 including salary and benefits (AWC 2006 salary survey) then the additional staff time would cost \$112,700 for the initial set up of the new program. Because each party will have costs in setting up the system, LGFN is splitting the estimated cost between county government and city government.

ONGOING COSTS -- Assuming each of the nearly 18,000 case records requires 15 minutes to process and forward (AOC fiscal note), there would be a requirement for 4,500 hours of new prosecuting attorney clerk time statewide. This is roughly 2.25 FTE. Each FTE costs approximately \$46,000 including salary and benefits (AWC 2006 salary survey). Thus the additional staff time would cost \$103,500 annually for notification of the WSP.

DISCUSSION:

Section 1 mandates that the prosecuting attorney notify the WSP of all appropriate convictions. It is not clear what the status of DUI conviction information transfer to WSP is at present. WSP receives some DUI information now, these include any convictions linked to felonies, and many that include fingerprint data. The filing system used by WSP requires fingerprint data to function. RCW 43.43.735 requires local law enforcement fo submit fingerprint data for all arrests. Fingerprint data is collected at the time of booking. Many DUI arrests are conducted in the field and the offender is released to another party rather than taken to a booking facility. If the offender is subsequently convicted there is no fingerprint data to be forwarded to the WSP. The bill makes the forwarding of this information a responsibility of the prosecuting attorney.

This provision will have a fiscal impact on county government. Currently prosecuting attorneys notify WSP of all felony convictions, but not all gross misdemeanor convictions. According to SGC there were 39,364 charges for DUI and Physical Control in 2006 leading to 17,796 convictions. Seventy-two percent of the charges were filed in district courts, and the remaining 28 percent were filed in municipal courts.

In order for prosecuting attorney staff to fulfill the requirements of Section 1, they will need to create a new mechanism to collect the data from municipal courts, as those cases are handled by city attorneys and not the prosecutor's office.
