Senate Bill 5754 addresses the responsibility for noxious weed control on state lands.

Section 1(3) allows for liens against lands owned by the state for expenses accrued by county weed boards to control noxious weeds on those state properties. Currently, lands owned by the state are exempt.

By statute, State Parks is already required to control noxious weeds on its lands, and the agency strives to carry out this work. The agency is responsive to notices issued by county noxious weed control boards. It is unlikely that a weed control situation would reach the point where a lien would be placed on any State Parks property. Therefore, this bill is not likely to have a fiscal impact on State Parks.

Section 1 removes the exemption that precludes county noxious weed control boards from placing a lien on state lands if the state agency that owns the land does not control weeds appropriately.

Section 1. (3): If the owner does not take action to control the noxious weeds in accordance with the notice, the county board may control them, or cause their being controlled, at the expense of the owner. The amount of the expense constitutes a lien against the property and may be enforced by proceedings on the lien, including on lands owned by the state.

Section 2. Exempts state lands from being subject to a lien for unpaid assessments.

The Department of Natural Resources (DNR) assumes that inspections and notifications by the weed board will not increase with this bill, therefore the response by DNR to noxious weed issues will be the same and have no fiscal impact.

Senate Bill 5754 authorizes county noxious weed control boards under RCW 17.10.170 to place liens against public lands for unpaid expenses accrued for noxious weed control work performed by the county weed board.

Because enforcement proceedings are not conducted by the state noxious weed control board, this bill does not have a fiscal impact to the Washington Department of Agriculture (WSDA).

Part IV: Analysis

A. SUMMARY OF BILL

Provide a clear, succinct description of the bill with an emphasis on how it impacts local government.

The bill removes the exemption for state lands from the use of lien proceedings to recoup costs to counties of noxious weed control.

B. SUMMARY OF EXPENDITURE IMPACTS

Weed districts that have a large amount of state land within their jurisdiction could incur cost savings to streamline enforcement of noxious weed laws. The amount of enforcement by weed districts on state lands varies by jurisdiction so the cost savings are indeterminate. A survey of 14 weed districts found zero instances of enforcements on state lands in 2016.

As an illustrative example, a weed district spent approximately \$10,000 to enforce laws regarding two noxious weeds on Department of Natural Resources land. Under the new bill, they would be guaranteed to recoup their costs.
