# Part II: Narrative Explanation

#### II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Section 1 - The Local Creative Districts legislation charges the Washington State Arts Commission with providing leadership and a helping hand to local governments, local communities and federally recognized Indian tribes desirous of certifying a part of their territory as a Creative District.

Section 2 - (2) Creates a new definition of "Coordinator" employed by the Washington State Arts Commission. Section 2 - (3) Creates a "State-certified creative district" requiring approval by the Washington State Arts Commission.

Sections 4 and 5 - This measure has moderate fiscal impact on the Washington State Arts Commission. In the first biennium the agency will hire a contractor to begin researching the new program. The Agency will need to hire a Creative Districts Coordinator to manage and evolve the program. In the first biennium, the Agency will hire a contractor to begin researching the new program. The Agency will need to hire a Creative Districts Coordinator to manage and evolve the second biennia and beyond, the fiscal note includes salary and benefits for one coordinator, a slim budget for travel, and additional budget items permitting meaningful technical and professional support for communities pursuing Creative District Certification.

Section 4, subsection (9) limits funding to \$156,000 for the first biennium and \$235,000 the second year and requires \$40,000 in grants each year.

Sections 4 and 5 - The Washington State Arts Commission (Arts Commission) shall employ a coordinator to work with the public and the Arts Commission to develop criteria for a statewide Creative District program; a certification process and forms; a review process; a denial, revocation and appeal process; and develop an incentive process for state-certified creative districts. The coordinator will be tasked with the provision of technical assistance and planning help. In the first two years of implementation a contractor will be hired to begin research, coordination, meeting with community leaders and development of the new program.

Ongoing costs in future biennia include salary, benefits, office expenses, travel, and incentives in the form of grants for state-certified creative districts. For purposes of this Fiscal Note the Agency assumes we would have funds or processes available to incentivize successful applications at \$40,000 in grants each year. The Agency assumes it will be challenging to be able to grant \$40,000 in the first year when the criteria, processes and forms will not be finalized, making it difficult to select qualified creative districts to receive grants.

New subsection (9) in Section 4 limits the funding to \$156,000 per biennium or \$78,000 per year including \$40,000 in grants each year. In the second biennium it limits funding to \$235,000 per biennium or \$117,500 per

year including \$40,000 in grants each year. The proposed funding for the first biennium is insufficient to hire an employee, pay benefits and enterprise services and award the minimum required \$40,000 in grants. The Agency assumes with this amount of funding that hiring a contractor for the first two years allows the Agency to meet the \$78,000 per year. In the second biennium when the funding is higher, the Agency will dedicate a coordinator position to the program. Hiring an employee allows for someone on site, sharing resources from the Agency, oversight by the Agency and inclusion with statewide planning within the Agency and meets the definition outlined in Section (2).
