This bill makes no changes to the frequency or process for persons checked for felony offenses by the Office of the Secretary of State. This bill may slightly reduce the number of potential persons flagged for felony offenses as some persons convicted of felonies would no longer be considered under the authority of the Department of Corrections.

Because of the change in the oath, this bill would require reprinting about 250,000 new voter registration forms at the cost of \$0.099 each for a total fiscal impact of \$24,799. This would be a one-time expenditure because future voter registration forms would be printed with the updated oath.

An ACT relating to voter eligibility for persons who have been convicted of a felony offense.

Amends RCW 10.64.140 "Loss of voting rights – Acknowledgment" by changing the right to vote from provisionally to be automatically restored as long as the defendant is not under the authority of the Department of Corrections (DOC) and by stating that a person serving a term of community custody is not considered to be in the custody of the department for purposes of this section unless the person is returned to confinement for a violation of community custody pursuant to RCW 9.94A.633(2).

Amends RCW 29A.08.520 "Felony conviction – Provisional and permanent restoration of voting right" by stating that a person who has had their voting rights restored must reregister to vote before voting.

Amends RCW 29A.08.230 "Oath of applicant" by modifying the language in the voter registration oath to reflect the new definition of being "under the authority of the DOC."

Amends RCW 29A.40.091 "Envelopes, declaration, and instructions—Voter's oath—Overseas and service voters —Return of ballots—County auditor's name" by clarifying the voter declaration provided to each voter must be updated by the time materials are distributed for the 2020 general election to reflect the changes in the definition of being "under the authority of the DOC."

Amends 72.09.270 "Individual reentry plan" by stating that DOC shall provide the offender with voter registration materials in accordance with RCW 29A.08.520.

Effective date is assumed 90 days after adjournment of session in which this bill is passed.

## **Part IV: Analysis** A. SUMMARY OF BILL

#### COMPARISON OF CURRENT BILL VERSION TO PREVIOUS:

The substitute bill modifies the language in the voter registration oath to state: "I am not currently confined in a state correctional facility in Washington, incarcerated for a felony conviction entered in a federal court, or incarcerated for a felony conviction entered in a state court other than a Washington state court." This declaration must be updated by the time voting materials are distributed for the general election in year 2020 to reflect that a person may not vote if he or she is confined in a state correctional facility in Washington, or is otherwise disqualified under RCW 29A.08.520(1).

#### SUMMARY OF CURRENT BILL VERSION:

This bill would restore the right to vote immediately after a felony conviction as long as the person is not under the authority of the Department of Corrections. Currently, the right to vote is provisionally restored.

A person serving a term of community custody is not considered to be in the custody of the Department, unless the person is returned to confinement for a violation of community custody pursuant to RCW 9.94A.633(2).

A person who has had their voting rights restored must reregister to vote prior to voting. If a registered voter is not eligible to vote, the Secretary of State or the County Auditor must confirm the match through a comparison of, if available, the name, date of birth, last known address and county of residence, and driver's license number of the last four digits of the social security number, and unless within 90 days of an election, suspend the voter registration from the official state voter registration list.

The declaration must be updated by the time voting materials are distributed for the general election in year 2020 to reflect that a person may not vote if he or she is confined in a state correctional facility in Washington, or is otherwise disqualified under RCW 29A.08.520(1).

### **B. SUMMARY OF EXPENDITURE IMPACTS**

This bill would have an indeterminate expenditure increase for county auditors to confirm and suspend a voter registration. It is unknown how many ineligible voters would register after the change from provisional to full restoration of voting rights occurs. Nor the number of hours required by auditors to confirm this ineligibility.

Updating the voting materials to include the declaration in time for the general election in year 2020 would have minimal, albeit indeterminate, costs to counties associated with additional printed ballot pages. The number of additional ballot pages would vary by jurisdiction.
