Part IV: Capital Budget Impact

This bill would amend RCW 18.155, adding a definition for "qualified supervisor" in the context of sex offender treatment providers, and details professional qualifications and work experience required.

The bill would amend RCW 18.155.030 and 18.155.075 to replace "certified sex offender treatment provider" with "qualified supervisor" and 18.155.080 adding more detail to standards and procedures for approval, directing specific circumstances under which an applicant must be approved, including detailed criteria for out of state applicants.

The bill would allow applicants to attest to training requirement completion rather than submit proof, unless requested.

The bill would create the "Sexual Offender Treatment Provider Advisory Committee", a permanent body that would require participation by one superior court judge. Terms of committee participation would be defined as six years in duration and the Committee would tasked with providing advice to the Department of Social and Health Services regarding standards, individual applications, maintaining the pool of treatment providers, and reforms needed. Travel expenses for committee members would be reimbursed.

This bill would require a superior court judge to participate as a member of the newly created committee. Participation in the Committee would be permanent. II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Section 1: Amends RCW 18.155.020 (Sex Offender Treatment Providers–Definitions.) adding the definition of a qualified supervisor.

Section 4: Amends RCW 18.155.080 (Sex Offender Treatment Providers–Standards and procedures.)1) Allowing credit for experience obtained through work in an institutional setting in Washington or in another state or territory of the United States;

2) Certifying applicants who have a comparable certification in another jurisdiction who:

a. Hold or have held within the past thirty-six months a credential in good standing from another state or territory of the United States or;

b. Meet a lifetime experience threshold of having provided at least two thousand hours (2,000) of direct sex offender specific treatment and assessment services and continue to maintain professional involvement in the field.

3) Allowing the applicant to sign an attestation form indicating participation in the required training and to substantiate the attestation with hours of training, if such substantiation is requested.

Section 5: Adds a new section to chapter 18.155 RCW (Sex Offender Treatment Providers) establishing a nine-member Sex Offender Treatment Provider Advisory Committee. The Secretary of the Department of Health will appoint the committee members which must consist of three sex offender treatment providers, a superior court judge, a mental health practitioner, a defense attorney, a representative from the Washington association of prosecuting attorneys, a representative from the Department of Social and Health Services, and a representative from Washington State Department of Corrections. The committee members will meet as necessary to conduct business and will be reimbursed for travel.

II. B - Cash receipts Impact

Current law RCW 43.70.250 (License fees for professions, occupations, and businesses.) requires that heath professions be fully self-supporting and that sufficient revenue be collected through fees to cover the cost of administering the program.

The Department of Health (department) does not anticipate the need to increase licensing fees to support the changes proposed in this bill. The sex offender treatment provider (SOTP) program has a sufficient fund balance to support the increased costs. The department will monitor the SOTP program fund balance, and will adjust fees over a six (6) year period to ensure that fees are sufficient to cover all program expenditures.

Rulemaking

Section 4: Department staff will develop and adopt rules to update definitions and add other ways to be a SOTP professional. This will include two rules workshops and one formal rules hearing, all meetings will be held in

free facilities. Assistant Attorney General time will be one day for each stakeholder meeting and the formal rules hearing. Costs include staff and associated costs and Office of the Attorney General support in the amount \$3,800. One-time costs for rulemaking will be 0.10 FTE and \$20,000 in FY 2021.

Information Technology

Section 4: During FY 2022, health technology services (HTS) staff will update Integrated Licensing & Regulatory System (ILRS), including configuration to do workflow updates and supervision updates. In FY 2022, one-time costs will be \$4,000.

Office of Customer Service

Sections 2-3: This bill changes the requirement that supervised hours be under the supervision of a certified SOTP to being under the new defined qualified supervisor. This changes the requirements of issuance of an affiliated SOTP certification to proof of supervision. Based on these changes the credentialing section will have an increase in the number of SOTP applications received. In FY 2022, one-time costs will total 0.10 FTE and \$11,000. Starting in FY 2023 and ongoing, costs will be \$1,000 each year.

Program Implementation & Administration

Section 5: Staff will complete activities to recruit and fill the committee member positions in FY 2022. Ongoing costs are associated with the management of the program and committee. Program implementation costs will include staff and associated costs from interviewing five groups of interviewees which would include developing and posting announcements, reviewing applications, setting up interviews, conducting interviews, debrief and decision making, then secretary approval. This cost will include Health Services Consultant 4, Health Services Consultant 2, Executive Director, and Secretary Senior time for a total of 0.50 FTE and \$69,000 in FY2022. Starting in FY 2023 and ongoing, program administration costs would include nine meetings a year, travel, and other associated costs. The department assumes increased involvement and will cost 0.40 FTE and \$64,000 each year.

Sex Offender Treatment Provider Advisory Committee

Section 5: In FY 2022, the secretary will appoint nine members to the Sex Offender Treatment Provider Advisory Committee. The department anticipates this committee will have nine meetings per year. Meeting activites will consist of advising the Secretary of Health on certification procedures; maintaining standards on individual applications for certification; issues pertaining to maintaining a healthy workforce; and making recommendations for reform of regulatory or administrative practices. Costs for the nine committee members will include travel and associated costs between \$300 - \$400 per day for each committee member to attend these meetings. In FY 2022 and ongoing, costs will be \$31,000 per year.

Total costs to implement this bill: FY 2021 – 0.1 FTE and \$20,000 FY 2022 – 0.6 FTE and \$115,000 FY 2023 through FY 2025 – 0.4 FTE and \$96,000

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Briefly describe by section number, the significant provisions of the bill, and any related workload or policy assumptions, that have revenue or expenditure impact on the responding agency.

This bill is related to the increase of availability of certified sex offender treatment providers by amending chapter 18.155 RCW.

Section 1(4) adds the definition of qualified supervisor. It states that a qualified supervisor is a person who meets the requirements for certification as a sex offender treatment provider, whether or not the person is currently certified, or has provided at least two thousand hours of direct sex offender treatment and assessment services while continuing to maintain professional involvement in the field. A qualified supervisor may sign attestation forms, indicating they have met the requirements, in lieu of documentation being submitted.

Section 4(1) states that an establishment of standards and procedures for approval will include educational programs and alternative trainings which, must allow credit for experience obtained through work in institutional settings within Washington, or territories of the United States.

Section 4(3) is amended to add that qualifying applicants, who have comparable certification in another jurisdiction, must be allowed to receive certification if they currently have, or have had, credentials, in good standing from another state within the last 36 months, that is equivalent to the sex offender treatment provider certification within Washington State. Alternatively, the person can meet a lifetime experience threshold of having provided at least two thousand hours of direct sex offender treatment and assessment services while continuing to maintain professional involvement in the field.

Section 4(8) adds that an applicant is not required, in all cases, to submit complete documentation of their training but can sign attestation forms indicating their participation in the required training and meeting the requirement of hours of training if substantiation is requested.

Section 5 states that the sexual offender treatment provider's advisory committee will be reestablished and members of the board will include the secretary of DOC, or the secretary's designee.

Effective date is assumed to be 90 days after adjournment of session in which this bill is passed.

We assume this bill will have no fiscal impact to the Department of Corrections (DOC).

This proposed bill broadens the requirements of the sex offender treatment provider certification allowing those who have worked in the field, for at least 2000 hours, to supervise others and, in addition, will also allow individuals from other states, with similar certifications, to transfer their certification to Washington State. The revision would also permit individuals working in an institution and the Special Commitment Center to earn

credit towards their certification. Although this would have no fiscal impact to DOC, it would have a positive effect on the recruitment and retention of the Sex Offender Treatment and Assessment Program as well as increase the number of qualified providers in Washington State.

If enacted, the sexual offender treatment provider's advisory committee will be reinstated which will require the Secretary, or Secretary's designee, of DOC to be an active member. The board will be led by Department of Health and DOC will participate within existing resources.

Part IV: Analysis A. SUMMARY OF BILL

Provide a clear, succinct description of the bill with an emphasis on how it impacts local government.

This bill would require the Department of Health (DOH) to certify sexual offender treatment providers (SOTPs) who receive supervision from qualified supervisors who do not themselves have to be certified SOTPs. The bill would also require the DOH to certify sexual offender treatment providers with out of state qualifications if they meet a lifetime experience threshold or meet other requirements. Finally, the bill would reestablish the Sexual Offender Treatment Provider Advisory Committee to advise the DOH and recommend regulatory and policy reform.

Section 5 would add a new section to reestablish the Sex Offender Treatment Providers (SOTP) Advisory Committee as a permanent body with members appointed by DOH to include:

- one superior court judge;
- three certified SOTPs with a minimum of five years of experience treating sex offenders;
- one mental health practitioner with experience treating victims of sexual assault;
- one defense attorney with experience representing persons charged with sex offenses;
- one representative of the Washington Association of Prosecuting Attorneys (WAPA);
- the Secretary of the Department of Social and Health Services (DSHS) or their designee; and
- the Secretary of the Department of Corrections (DOC) or their designee.

Committee members would be reimbursed for travel expenses in accordance with RCW 43.03.050 and RCW 43.03.060.

B. SUMMARY OF EXPENDITURE IMPACTS

Briefly describe and quantify the expenditure impacts of the legislation on local governments, identifying the expenditure provisions by section number, and when appropriate, the detail of expenditures. Delineate between city, county and special district impacts.

Section 5 would lead to an increase in expenditures for counties due to putting a WAPA representative and a defense attorney with experience representing persons charged with sex offenses on the SOTP Advisory Committee. The WAPA representative would likely be a county prosecutor, but it is unclear whether or not the defense attorney appointed would be a public defender or a private practice defense attorney. In addition, the bill does not specify the travel or time commitments required of committee members, although the Administrative Office of the Courts estimates at least two committee meetings per year, so the increase in county expenditures from this section is indeterminate.

C. SUMMARY OF REVENUE IMPACTS

Briefly describe and quantify the revenue impacts of the legislation on local governments, identifying the revenue provisions by section number, and when appropriate, the detail of revenue sources. Delineate between city, county and special district impacts.

Section 5 would lead to an increase in revenues for counties due to reimbursing committee members for travel expenses in accordance with RCW 43.03.050 and 43.03.060. However, the bill does not specify the travel or time commitments required of committee members from local governments, although the Administrative Office of the Courts estimates at least 2 committee meetings per year, so the increase in county revenues via reimbursement for such expenditures is indeterminate.
