An act increasing access to behavioral health services for minors.

The current substitute version differs from the previous version by:

- Sec. 1 adds language requiring the dedicated full-time employee also monitor the health care authority (HCA) website to ensure the website information is accurate and designed in a manner that is accessible to families
- Sec. 4 (state office of behavioral health consumer advocacy) language is amended adding two
 parents/caregivers rather than one parent, and two representatives from Medicaid MCOs to the
 statewide advisory council.

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Sec. 1 – Requires HCA to dedicate at least 1 FTE to connect stakeholders with current info about behavioral health (BH) services for minors, policies, and legislation through communications strategy and materials, outreach, and ensuring website information is accurate and designed in a manner that is accessible to families. [RCW 71.34]

Sec. 2 – Requires HCA to design a "parent portal", through a stakeholder engagement process, that connects families to BH services in their communities across the continuum of care and all related systems (BH, physical health, schools, child welfare). [RCW 71.34]. This section further requires HCA to submit a report to the governor and legislature by November 1, 2022, on the design and the needed resources to implement the portal.

Sec. 3 – Requires HCA to add and report on "live stakeholder engagement events" to solicit feedback on Family Initiated Treatment (FIT). Further requires HCA to report to the governor and legislature annually on the results of the stakeholder engagement efforts, including any recommendations for statutory changes identified as needed based on stakeholder engagement efforts results. The first report is due November 1, 2022, and the final report is due November 1, 2024. This section expires December 31, 2024. [RCW 71.34.3871]

HCA requests \$352,000 in FY-2023, \$584,000 in 2023-25 biennium, \$304,000 in 2025-27 and ongoing.

Sec. 1 – Requires HCA to dedicate at least 1 FTE to connect stakeholders with current info about Prenatal-25 behavioral health (BH) services, policies, and legislation through communications strategy and materials, outreach, and ensuring website information is accurate and designed in a manner that is accessible to families. This will require additional staff resources. HCA estimates needing:

 1.0 FTE – Communications Consultant 4 (CC4) to perform the stakeholder outreach in Sections 1 and will provide additional stakeholder support for Sections 2 and 3 of this bill.

Sec. 2 and 3 – Section 2 requires HCA to design and possibly implement a "parent portal", through a stakeholder engagement process, that connects families to BH services in their communities across the continuum of care and all related systems (BH, physical health, schools, child welfare). Section 2(1) appears to require design AND implementation of the parent portal, a further read of the section seems to imply that the report due on November 1, 2022, is meant to detail what the agency will need to implement the portal. Therefore, for the purposes of this fiscal note, HCA assumes it is only required to work with stakeholders to design and plan the portal and submit a report; this bill does not require implementation of the portal.

Section 3 requires HCA to conduct stakeholder engagement efforts with parents, youth, and behavioral health providers to measure the impacts of implementing policies resulting from chapter 381, Laws of 2019 during the first three years of implementation and sections 1 and 2 of this bill. The agency must submit its initial report on the results of the engagement on November 1, 2022, and annually thereafter until November 1, 2024.

The stakeholder outreach, design work for the parent portal, and report writing would need to begin July 1, 2022. To accomplish this work, HCA will need:

- 1.0 FTE IT Business Analyst (Journey). This position shall be responsible for the following activities:
 - Section 2: Oversee stakeholder and development work associated with the parent portal and compose the report due on November 1, 2022; and
 - Section 3: Lead the stakeholder engagement efforts, which must be completed by October 1, 2022, and then annually thereafter by July 1, 2023, and July 1, 2024. Also, this position will compose the annual reports required, starting November 1, 2022, to November 1, 2024. This position will need to start July 1, 2022, and will be on-going until December 2024, which is when this section of the bill expires.

Goods and services, travel, and equipment are calculated on actual program averages per FTE.

Indirect administrative costs for other agency support activities are calculated at \$39,000 per 1.0 FTE. This cost is included in Object T based on HCA's federally approved indirect rate. For the purposes of this fiscal note, this indirect cost is reflected as a Fiscal Analyst 3 but will be used to support all support activities to implement this bill.
