Part IV: Analysis A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

Overview: This legislation seeks to expand and clarify the procedures surround the seizure of animals and the petition process for owners seeking the release of their seized animal.

Sec. 2: Amends RCW 16.52.085 by adding and removing language. (1) Defines "minimum care", "physical infirmity", "physical injury", and "serious physical injury or infirmity".

(2) (a) If a law enforcement officer or animal control officer has probable cause that an owner or care taker violated this chapter, after getting a warrant, they shall enter the premises where the animal is located and seize the animal.

(b) If a law enforcement officer or animal control officer has probable cause that an animal is in imminent danger or is suffering serious physical injury or infirmity, or needs immediate medical attention enter onto private property without a warrant.

(3) (a) Establishes that the seized animal can be placed into animal care and control, foster care, a nonprofit animal sanctuary, or nonprofit rescue organization to receive minimum care.

(b) If the animal is place into foster care, a nonprofit animal sanctuary or rescue organization, the seizing agency shall retain constructive custody of the animal and must ensure the animal receives minimum care. The custodial agency may draw from the bond under subsection (5) of this section and distribute the funds to the foster home, authorized humane society, sanctuary, or rescue organization that is providing minimum care to the animal.

(4) Establishes that the owner must be given notice of their right to petition within the 72 hours following the seizure.

(5) Outlines the court procedures for both the owner and custodial agency during the petition process.

B. SUMMARY OF EXPENDITURE IMPACTS

Expenditure impacts of the legislation on local governments with the expenditure provisions identified by section number and when appropriate, the detail of expenditures. Delineated between city, county and special district impacts.

This legislation would have an indeterminate expenditure impact on local governments. The custodial agency would become responsible for the cost of the minimum care received by the seized animal until the owner of the seized animal posts their bond. Revenue from bonds (detailed under Revenue Impacts) would help defray some of those costs, but the extent to which those costs could be mitigated would depend on if those services were available locally and if the owner of the seized animal posted bond. It is possible that expenditures may exceed revenue and would result in a net increase in local expenditures but this amount cannot be predicted in advance.

C. SUMMARY OF REVENUE IMPACTS

Revenue impacts of the legislation on local governments, with the revenue provisions identified by section number, and when appropriate, the detail of revenue sources. Delineated between city, county and special district impacts.

This legislation would have an indeterminate revenue impact on local governments. There is no way project the amount of revenue generated from the payment of petitioning owners bonds cannot be predicted in advance. The amount of bonds revenue could cover the cost of the minimum care received by the seized animal while in custody of the custodial agency although some owners may not post bonds and therefore revenue may not match expenditures.
