II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

Section 4 is added to 70.54 RCW, requiring the Department of Health (Department) to post and periodically revise on its website information about substance use trends, overdose symptoms and response, and the secure storage of prescription drugs, over-the-counter medications, and firearms and ammunition.

This bill requires public education entities to make available Department of Health (department) covered topics such as substance use trends, overdose symptoms and response, and medications and firearm safe storage. Educational service districts must communicate department information no less than four times a year. The department is also required to post and periodically revise website information about substance use trends, overdose symptoms and response, and the secure storage of prescription drugs, over-the-counter medications, and firearms and ammunitions. The department is required to make this information accessible to school districts, charter public schools, state-tribal compact schools, and educational service districts. The information provided must include contact information for public health agencies, easily shared, and include format and content options for regional, demographic, and cultural differences.

Note: This bill was presented the 2022 legislative session as 1759 HB. Last fiscal note was for the substitute version. Cost assumptions have changed since better information on implementation noted below.

Assumptions

Section 4 requires the department to work with Tribal governments to engage with state-tribal compact schools. The department will also provide translations needs and different types of communication mediums for schools to connect to.

These are data that are already collected by the department. No new data collection will be needed for this bill. The department would add a web page specific to these topic areas that school districts can link to that is updated regularly. This would require a stakeholder engagement process in FY 2024 to ensure the web page meets the needs of school districts, and ongoing maintenance in FY 2025 and beyond. The department will translate the information on the website into the top three languages and produce fact sheets in those languages available on the web page.

0.25 FTE FY2024 and ongoing Health Services Consultant 3 to coordinate with the epidemiologist to develop and plain talk content for the webpage, update and maintain the web content, coordinate with Office of Superintendent of Public Instruction (OSPI) and department program staff to announce requirement and webpage.

1.0 FTE FY2024 Communications Consultant 4 and associated staffing costs are needed to do initial build, post, and at least annually revise on its website information about substance use trends, overdose symptoms and response, and the secure storage of prescription drugs, over-the-counter medications, firearms, and ammunition. This will require coordination with subject matter experts to transform data into family and student friendly reporting. In addition, Communications Consultant will work with translation services to translate the information from the website into fact sheets in the top three languages spoken in Washington, which will be produced annually upon updating data on the website. Ongoing costs for regular maintenance and updates can be managed with existing resources.

0.1 FTE for 2024 and 2025 Management Analyst 5 is the Equity and Social Justice Strategist actively collaborates with and advises program and office staff/leaders on how best to integrate and implement equity and social justice principles into office/program-specific work. This legislation specifically calls out state-tribal compact schools, and this position will provide leadership in connecting with Tribal governments and tribal health organizations as appropriate. They are the subject matter expert on community engagement and partnership development and provides consultation and technical assistance to offices and programs on these areas and coordinates alignment with the agency's commitment and approach on these issues.

FY2024 and ongoing 4 fact sheets for the identified topics in the bill produced annually available on website available in Spanish, \$78/300 word document; Russian and Vietnamese: \$84/300 word document; totaling \$984 annually.

Also includes other standard agency costs that include staff and associated expenses (including goods and services, travel, intra-agency, and indirect charges.

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

Section 1 of the bill is a finding and intent section.

Section 2 requires that within existing resources, each school district that maintains a website must post a prominent link on their homepage, and the homepage of each school within the district, to information from

the Department of Health (DOH) that addresses substance use trends, overdose symptoms and response, and the secure storage of prescription drugs, over-the-counter medications, and firearms and ammunition.

Each school district, for the purpose of informing students, families, and other persons about available health and safety resources, must also make the DOH information accessible through other internet-based communications, such as social media accounts used by the district, and through other digital and nondigital communications of the district. The required information postings may be made multiple times annually and no less frequently than twice each school year. The website and other communication requirements for school districts pertaining to the delineated information from the DOH applies also to charter schools, and state-tribal compact schools.

Section 3 requires that within existing resources, each educational service district (ESD) that maintains a website must post a prominent link on their homepage, and the homepage of each school within the district, to information from

the Department of Health (DOH) that addresses substance use trends, overdose symptoms and response, and the secure storage of prescription drugs, over-the-counter medications, and firearms and ammunition.

Each ESD, for the purpose of informing students, families, and other persons about available health and safety resources, must also make the DOH information accessible through other internet-based communications, such as social media accounts used by the district, and through other digital and nondigital communications of the district. The required information postings may be made multiple times annually and no less frequently than quarterly.

Section 4 requires that the DOH must post and periodically revise on its website information about substance use trends, overdose symptoms and response, and the secure storage of prescription drugs, over-the-counter medications, and firearms and ammunition. The information must be provided or otherwise made accessible to school districts, charter schools, state-tribal compact schools, and ESDs, and must be formatted for the needs of public-school students and families.

The posted information must be in the form of a template that can be revised as necessary and that:

Includes website addresses and telephone numbers of one or more public health agencies with applicable information.

May include website addresses and telephone numbers of one or more private organizations with applicable information.

Can be replicated for other health and safety topics that are germane to public schools.

Can be easily and readily shared with schools and districts. And

Includes format and content options that schools and districts may use to reflect regional, demographic, and cultural differences.
