Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

The bill would amend RCWs 26.26A, 13.34, 2.53, related to proceedings to preclude establishment of parentage when a parent alleges that a person committed a sexual assault that resulted in the parent becoming pregnant and subsequently giving birth to a child.

Section 1 amends RCW 26.26A.465, the court must appoint an attorney for an indigent petitioner and respondent in a proceeding under this section. OCLA is responsible for implementing. State shall pay costs of legal services.

Section 2 adds a new section to chapter 2.53 RCW, instructs OCLA to administer money given by legislature for legal services provided by appointed attorneys and enter into contracts with attorneys and agencies.

Section 3 amends RCW 13.34, adds to the definition of parent to include where a court has entered a final order precluding person from establishing or maintaining person's parentage of child.

Section 4 amends RCW 13.34, visitation may not be provided to an alleged perpetrator of sexual assault that resulted in parent becoming pregnant and subsequently giving birth following the filing of a petition before fact-finding, or petition has been dismissed unless both are satisfied; alleged perpetrator has a bonded and dependent relationship with the child that is parental in nature; and court finds that best interest of child for visitation to occur.

Section 6 amends RCW 13.34, instructs the court hearing dependency petition shall grant any request for concurrent jurisdiction to allow parent to file petition alleging person committed a sexual assault that resulted in parent becoming pregnant and giving birth.

Section 7 adds new section to chapter 13.34 RCW, the court shall require an alleged perpetrator to appear remotely in proceedings under this chapter to minimize trauma to parent who filed petition until court holds a fact-finding hearing or when petition is dismissed.

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

The bill is in regards to proceedings to preclude establishment of parentage when a parent alleges that a person committed a sexual assault that resulted in the parent becoming pregnant and subsequently giving birth to a child.

Section 1(4) changes the ability for a parent to seek preclusion of parentage in sexual assault case from four years to ten years after the birth of the child.

Section 1(5) requires a fact-finding hearing within 75 days unless there are exceptional circumstances.

Section 1(12) requires the court to appoint an attorney for the petitioner or respondent if they are indigent and meeting outlined circumstances.

Section 2 is a new section which requires OCLA to enter into contracts to provide legal services in preclusion proceedings, and must remain within appropriated amounts.

Section 3(19)(b) modifies the definition of a "parent" to exclude a person against whom a court has entered a final order removing the person from establishing or maintaining parentage of a child.

Section 4(9)(f) modifies visitation of the perpetrating parent and the child to not be allowed prior to fact finding or dismissal of the petition unless both the parent and child are shown to have a bonded relationship and the court finds it in the best interest of the child.

Section 6(4) adds concurrent legal jurisdiction is allowed under this bill with dependency court.

Section 7 is a new section that requires the perpetrating parent to attend proceedings remotely until fact finding.
