Part 2 - Explanation

This bill requires DOL to begin licensing data brokers.

2.A - Brief Description Of What The Measure Does That Has Fiscal Impact

Sec. 1 – New Section

- (1) "brokered personal data" means any of the following computerized data elements about a resident individual if it's categorized or organized for sale/licensing another entity:
 - The individual's name or address, or either for a member of their immediate family/household
 - o The individual's date or place of birth
 - o The maiden name of the individual's mother
 - o The individual's biometric information
 - o The individual's SSN or any other government-issued identification
 - o Information that alone or in combination can be associated with the individual
- (2)(a) "business entity" means any of the following:
 - o Resident individual who regularly engages in commercial activity to generate income
 - A corporation, nonprofit, LLC, partnership or LLP, business trust, joint venture, or other business organization whose constitutent parts share a common economic interest
 - A financial institution defined in RCW 9A.56.280
 - An individual that controls, is controlled by, or is under common control with a person described in bullets 2 or 3
 - (b) "business entity" doesn't include the state, a state agency, a local government, or a business entity durng a period in which they are working solely on behalf of the state, state agency, or local government direction
- (3) "data broker" means a business entity, or part of, that collects and sells, or licenses brokered personal data to another person and doesn't include:
 - A consumer reporting agency, a person that provides information to them, or a user of a consumer report to the extent that they are subject to regulation under the federal fair credit reporting act
 - o A financial institution, affiliate, or a nonaffiliated third party to the extent that they are subject to regulation under Title V of the Gramm-Leach-Bliley act
 - A business entity that collects information about a resident individual if the individual is/was a user of goods/services, an employee/agent or someone in a contractual relationship with them, an investor, a donor, or in a similar relationship
 - A business entity that performs services for another entity described in the bullet above
- (4) "department" means DOL
- (5) "resident individual" means an individual residing in WA

Sec. 2 – New Section

- (1) prohibits data brokers from collecting, selling, or licensing brokered personal data within WA state unless they are registered with DOL (except as provided)
- (2) allows data brokers to collect, sell, or license brokered personal data without registering with DOL if it involves any of the following:
 - Providing publicly available information related to a resident individual's business/profession
 - Providing publicly available information as part of a service that provides alerts for health/safety purposes
 - Providing information that is available from federal, state, or local government records
 - Publishing, selling, or distributing access to journals, books, periodicals, newspapers, magazines, news media or educational works
 - Developing or maintaining an electronic commerce service/software
 - o Providing directory assistance/information services as a telecommunications carrier

 Selling business entity assets that's not part of the ordinary conduct of the business entity

Sec. 3 – New Section

- (1) requires data brokers to complete the following annually, on or before January 31st:
 - Submit a form that DOL specifies which includes their name, street address, telephone number, and primary website and email address
 - Pay a fee set by DOL in rule
 - DOLs fee shall be sufficient to cover the costs of administering the registration program
 - A declaration that includes:
 - A statement on whether resident individuals may opt out of all or a portion of the broker's collection, sale, or licensing of the resident individuals' brokered personal data
 - Identification of which activities of collecting, selling, or licensing personal data resident individual's are able to opt out of or permit the data broker to collect, sell, or license
 - Description of the method a resident individual may exercise the choices of form submittal or fee payment
 - A statement on whether a resident individual may authorize another person to exercise the choice in bullet 1 of this list, on their behalf and the appropriate process
- (2) requires DOL to approve the registration if a data broker applies with section requirements
 - o Registrations are valid until December 31st of the year in which DOL approves it
- (3) allows DOL to approve/renew a registration by an agreement with the nationwide multistate licensing system
 - Allows DOL to conform their practices to the requirements of the nationwide multistate licensing system in rule

Sec. 4 – New Section

 Requires DOL to make the information that business entities submit for registration publicly available on its website

Sec. 5 - New Section

- (1) allows DOL to impose civil penalties:
 - Of no more than \$500 for each violation of a data broker under this chapter or DOL's rules
 - Of \$500 per day for continuing violations
- (2) limits the total penalty amount imposed on a data broker in any calendar year to \$10,000
- (3) provides that the AG may recover an amount imposed by court action if a data broker fails to pay the civil penalty

2.C - Expenditures

DOL estimated 1100 licensees will be processed in the first year the based on licensee counts in other states. However, the number of licensees in these other states appear to be doubling every 2 years since 2019, putting our potential licensee count at 4000 by 2027.

The number of staff requested is dependent on the number of licensees. DOL will use the following professions as comparison:

Information Services:

The agency will use appropriated funds to hire contract programmers to accomplish this work or to support current staff implementing this legislation within the required timeline. Appropriated funds may also be used to hire agency temporary staff to support permanent staff assigned to this legislative effort.

Any change requires a process to ensure changes are correctly applied to the system. This involves Project Managers that manage the team that completes the update, business analyst that documents and reviews the system changes, architect services that analyzes how the update could have an effect on other systems or DOL processes, developers who create the change, and testers and quality assurance teams that ensure the update is working correctly.

Support Services:

Agency Administrative Overhead is included at a rate of 23.4 percent of the direct program costs. This funding received covers agency-wide functions such as vendor payments, contract administration, financial management, mail processing, equipment management, help desk support, and technical assistance to DOL employees.

What IS Will Implement:

- Create new profession in POLARIS for data brokers.
- Create ability to for data brokers to register, renew, and submit account change requests online or by paper.
- Add form fields to collect information from each data broker on residents' ability to opt out of data broker activities and the method for opting out.
- Update system to allow staff to process registrations and perform compliance activities.
- Create new registration fee.
- Add new profession to standard notifications and create new notification timing for annual registration reminder.
- Update scanners to route paper submissions to system.
- Update public license search to include data brokers and opt out information for each data broker.

Assumptions:

- Only businesses will register as data brokers.
- Registered data brokers must re-register and pay a fee annually.
- Existing functionality supports the reporting of complaints and other compliance issues by licenses, including status of complaint.
- No bonds/financial guarantees.
- The new license type will work with existing letters.
- Individuals will use existing search features on public portal to create a list of data brokers.
- Licenses will be selected for audit manually and not through an automated process.
