## Part II: Narrative Explanation

## II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

There is no change in cost from the prior fiscal note. Rulemaking is still necessary for both the Department of Health and the State Board of Health.

Section 1: The Department of Health (DOH) and the State Board of Health (SBOH) shall adopt rules requiring Group A water systems to notify their customers prior to starting fluoridation or 90 days prior to a vote on discontinuing fluoridation. Notification methods will be in accordance with those outlined in this bill section. Rulemaking will include corrective action for those water systems that violate the notification requirements.

### II. C - Expenditures

Rulemaking is needed to amend the Group A Public Water Systems WAC to include the elements of notifying customers when water systems consider discontinuing fluoridation. DOH and SBOH will conduct this work on these WACS, respectively and with cooperation with each other. Costs are listed out separately here.

In conjunction with rulemaking DOH will also perform an environmental justice assessment. Based on the environmental justice assessment, each covered agency must seek, to the extent legal and feasible and consistent with the underlying statute being implemented, to reduce or eliminate the environmental harms and maximize the environmental benefits created by the significant agency action on overburdened communities and vulnerable populations.

## Rulemaking DOH:

### **Assumptions:**

- Section 2 requires DOH to amend Public Water Systems WAC chapter 246-290 to include the required notification of starting or discontinuing fluoridation elements.
- Due to the potentially challenging aspects associated with the development of this rule, given the topic, extensive stakeholder work will be necessary and will take 2 years.

To complete this one-time work, DOH will require 0.5 FTE in FY 2024 and 0.3 FTE in FY 2025 to:

- Provide guidance and rule writing.
- Conduct an environmental justice assessment.
- Coordinate with stakeholders (including waters systems, state agency staff, local agency staff, local decision makers, and effected constituent groups), facilitate and participate in stakeholder meetings, and lead development of policy-heavy components of the rule.
- Arrange meeting rooms, take notes during stakeholder meetings, and deal with other logistical and communication issues associated with the rulemaking.

Attorney General time to review and advise on rulemaking will be \$1,000 in both FY 2024 and FY 2025.

Travel required for stakeholder meetings:

## Assumptions:

- Two subject matter experts from DOH will meet with stakeholders four times during the rulemaking process.
- Meeting space will be provided by local health partners at no cost.
- Meetings will be held in 4 locations: Spokane, Everett, Vancouver, and Yakima.
- Staff will carpool in state vehicles.
- All assumptions for costs in the fiscal note are based on similar rulemaking with similar work that the DOH has completed in the past.
- Travel is based on:
- Use of state vehicles and per diem costs

DOH rulemaking costs for FY 2024: 0.5 FTE and \$91,000 DOH rulemaking costs for FY 2025: 0.3 FTE and \$56,000

## Rulemaking SBOH:

SBOH will conduct rulemaking in FY 2024 and FY 2025 to adopt rules in chapter 246-290 WAC (Group A Public Water Supplies) to include new fluoridation notification elements. SBOH will work closely with DOH to coordinate the update of these rules along with DOH's rule updates to chapter 246-290 WAC.

To complete this rulemaking including analyses required by the Administrative Procedures Act, the Regulatory Fairness Act, and the Heal Act as well as interested party and community outreach coordination, SBOH will require 0.5 FTE and \$78,000 in FY 2024 and 0.5 FTE and \$81,000 in FY 2025. This includes Office of the Attorney General costs of \$1,000 in both FY 2024 and FY 2025.

SBOH rulemaking costs for fiscal year 2024: 0.5 FTE and \$78,000 SBOH rulemaking costs for fiscal year 2025: 0.5 FTE and \$81,000

## Part IV: Analysis

## A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

## CHANGES BETWEEN THIS VERSION AND PREVIOUS BILL VERSION:

Removed all of section 1 and the requirement for public water systems to seek and receive the most current information about the public health impacts of community water fluoridation from the department and its local health jurisdictions 90 days before a vote or decision from section 2.

#### SUMMARY OF CURRENT BILL:

This bill establishes the mandatory provision of a public notice by public water systems if they want to remove fluoride from their water source.

Sec. 1: If a public water system considers discontinuing the fluoridation of its water supply on a continuing basis they must notify its customers of its intentions at least 90 days prior to a vote or decision. Any public water system that violates the notification requirements of this subsection shall return the fluoridation of its water supply to its previous level until proper notification is provided under the provisions of this section.

## B. SUMMARY OF EXPENDITURE IMPACTS

Expenditure impacts of the legislation on local governments with the expenditure provisions identified by section number and when appropriate, the detail of expenditures. Delineated between city, county and special district impacts.

### CHANGES IN EXPENDITURE IMPACTS BETWEEN THIS VERSION AND PREVIOUS BILL VERSION:

The primary change made between versions was the removal of the requirement for public water systems to seek and receive the most current information about the public health impacts of community water fluoridation from the department and its local health jurisdictions 90 days before a vote or decision. This change would reduce expenditures for water systems by reducing the amount of work hours required to meet the requirements of the bill.

### EXPENDITURE IMPACTS OF CURRENT BILL:

This legislation would have an indeterminate expenditure impact on local governments. The only costs associated with this bill would be the costs associated with posting the required public notice. However, the costs associated with posting public notice are assumed to be minimal because most public water systems already post public notices and collecting the required public health information should not require much work time.
