II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

The differences between 1758 ESHB and 1758 HB are as follows:

Sections 2 (4) and 3 (1) add public utility districts to the list of entities covered by this bill, in addition to the Department of Fish and Wildlife and federally recognized Indian tribes.

The changes would result in no change in the fiscal impact to Ecology.

Under current law, Ecology works in partnership with local governments to implement chapter 90.58 RCW (Shoreline Management Act) to promote public access, encourage water-dependent uses, protect shoreline resources, and develop, adopt, and administer shoreline master programs (SMPs). RCW 90.58.355 and WAC 173-27-044 specify certain developments that are exempted from obtaining shoreline permits or local government reviews under SMPs.

This bill would create a new exception to routine maintenance activities at the Department of Fish and Wildlife (WDFW), tribal government, and public utility district fish hatcheries taking place within the existing hatchery footprint under the Shoreline Management Act (SMA), Chapter 90.58 RCW.

Section 1 would declare that fish hatcheries need routine maintenance.

Section 2 would amend RCW 90.58.355 to include fish hatchery maintenance activities, that are described in section 3, in the list of actions that need no formal review by local governments under the SMA.

Section 3 would add a new section to chapter 90.58 RCW to define the kinds of activities necessary to maintain the operation of fish hatcheries that would not require formal review under local SMPs. The activities would be required to be within the existing facility footprint. WDFW, tribal governments and public utility districts would be required to ensure compliance with the substantive requirements of the SMA, including not adversely affecting public access or shoreline ecological functions. WDFW, tribal governments and public utility districts would be required to notify both Ecology and local governments before conducting repair and maintenance activities that are allowed to bypass shoreline review.

Ecology assumes that amendments to WAC 173-27-044 would be necessary to incorporate the new statutorily created exception into rule. Ecology updates rules for the SMA on an ongoing cyclical basis. These changes to the update schedule would be included in Ecology's next rulemaking effort. Therefore, there would be no new fiscal impact from rulemaking as a result of this bill.

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

NO CHANGE FROM PREVIOUS FISCAL NOTE: Differences in this bill version do not change the fiscal impact for WDFW.

Section 2 grants an exemption to the Department of Fish and Wildlife (WDFW), federally recognized Indian tribes, or a public utility district from certain permits or reviews conducted by a local government, included in the Shoreline Management Act, that meet specific conditions.

Section 3 specifies that certain maintenance activities necessary to maintain the operation of fish hatcheries are exempt from certain permits or reviews, when undertaken by WDFW, a federally recognized Indian tribe, or a public utility district, including but not limited to: water intakes and discharges, fish ladders, water and power conveyances, weirs, and racks and traps used for fish collection. Requires proponents of projects to ensure compliance with the substantive requirements of the Shoreline Management Act and provide written notification to the local governments and the Department of Ecology, prior to beginning these maintenance or repair projects.

Section 2 exempts WDFW, federally recognized Indian tribes, and public utility districts from the requirement to obtain certain substantial development permits, conditional use permits, variances, letters of exemption, or other reviews when the maintenance or repair projects are necessary to maintain the operation of a state, tribal, or public utility district managed fish hatchery. As a result, WDFW will not be required to pay for certain local government permits. To estimate the savings, WDFW reviewed recent jobs:

Permit fees on hatchery work, especially shoreline permitting

Wallace River Hatchery; \$17,500 Minter Creek Hatchery; \$6,500

WDFW estimates doing two hatchery work areas per fiscal year and used the combination of the two costs above to generate an estimated savings of \$24,000 per fiscal year.

Section 3 requires project proponents to provide written notification of projects authorized to the affected local governments and the Department of Ecology, prior to beginning these maintenance or repair projects. The workload associated with this correspondence is expected to be nominal, therefore no fiscal impact.

Part IV: Analysis

A. SUMMARY OF BILL

CHANGES FROM PREVIOUS BILL VERSION

This substitute bill adds Public Utility Districts to the list of potentially permit-exempt parties when certain conditions are met.

SUMMARY OF CURRENT BILL VERSION

Section 1 describes legislative intent.

Section 2 amends RCW 90.58.355 [Shoreline Management Act – Persons, projects, activities for requiring certain permits... or local review] to list "projects undertaken by the Dept. of Fish and Wildlife, federally recognized Indian tribes, or Public Utility Districts that meet certain "conditions" as exempt from certain permits, variances, letters of exemption, or other local review.

Section 3 adds a new section to chapter 90.58 RCW [Shoreline Management Act] to describe eligible projects exempt from local review and describes obligations of the Dept. of Fish and Wildlife, federally recognized Indian tribes, and Public Utility Districts to receive exemptions.

B. SUMMARY OF EXPENDITURE IMPACTS

CHANGES FROM PREVIOUS BILL VERSION

This substitute bill adds Public Utility Districts to the list of potentially permit-exempt parties when certain conditions are met. This change expands the pool of potentially exempt parties and increases the scale of impact below.

SUMMARY OF CURRENT EXPENDITURE IMPACTS

This bill will result in an indeterminate decrease in expenditures for counties due to a decrease in workload for counties permitting eligible projects.

Public utility districts eligible for permit exemptions will experience an indeterminate cost savings due to decreased permitting costs.
