Section 2 of the bill adds new section to chapter 28A.230 RCW (Compulsory Coursework and Activities).

Section 2(1)(a) requires each public school to develop educational and promotional materials that incorporate the statement of student rights. These materials must be available on school and district websites, social media platforms, and other communication channels used by students. The materials must also be incorporated into civics education curricula. Section 2(1)(b) requires the Office of the Superintendent of Public Instruction (OSPI) to make the statement of student rights available on its website. OSPI is encouraged to include it in Temperance and Good Citizenship Day materials.
