Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

Section 2 amends RCW 43.160.020 to add a definition of broadband, which means a network of deployed telecommunications equipment and technologies necessary to provide high speed-internet access and other advanced telecommunications services.

Section 3 adds a new section to RCW 43.160 to codify the Community Economic Revitalization Board (CERB) Rural Broadband Program alongside existing CERB statute. This includes the authority to make high-speed, open access broadband grants and loans to local governments and federally recognized Indian tribes in rural and underserved communities to aid economic or community development.

Section 3(2) CERB must provide a funding application, but may not provide funding to projects with the primary purpose to promote retail shopping development or expansion or for backbone infrastructure solely to create a competitive network. CERB Broadband investments encourage, foster, develop and improve broadband to (1) drive job growth and creation, promote innovation, and expand markets for local businesses (2) serve the ongoing needs of the local education system, healthcare system, public safety system, industries, businesses, governmental operations, and resident needs. Tribal funding applications must be approved by tribe's governing body, and local government funding applications must be approved by the local associated development organization or local workforce development council.

Provides for de minimis general system improvements if they are critical to the project, and project prioritization, including the demonstration of a projects' value to the community, economic feasibility, local match and participation, a technology-neutral approach to provide internet access, inclusion of the project in applicable state plans, and a project's readiness to proceed to construction.

Section 3(3) requires an official representing the applicant must be present during board deliberations.

Section 3(4) prior to an award, the applicant must demonstrate that no other reasonably similar funding is available in a timely manner.

While there is no operating impact to the program, the overall capital budget impact is indeterminate. The proposed legislation would add the CERB Rural Broadband Program to existing CERB programming and would be funded from CERB capital appropriations. The distribution of broadband funding requests and awards compared to requests and awards that support communities to plan for and finance public infrastructure in support of private business development is not known. It is also unknown whether the proposed legislation would result in additional budget authority to provide funding for rural broadband infrastructure.

Part IV: Analysis A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

Section 1 adds a new section which states the bill's intent to establish an open-access broadband networks grant and loan program for local governments and federally recognized Indian tribes within the department of commerce.

Section 2 amends RCW 43.160.020 to include a definition of "broadband" to mean a network of deployed telecommunications equipment and technologies necessary to provide high-speed internet access and other advanced telecommunications services.

Section 3 adds a new section to chapter 43.160 which authorizes the community economic revitalization board to make loans and grants for the purpose of financing the cost of building broadband service infrastructure. This section also includes project eligibility and evaluation criteria for the broadband program.

B. SUMMARY OF EXPENDITURE IMPACTS

Expenditure impacts of the legislation on local governments with the expenditure provisions identified by section number and when appropriate, the detail of expenditures. Delineated between city, county and special district impacts.

This legislation would have an indeterminate expenditure impact on local governments.

Local governments which apply for grants or loans would incur costs associated with the application process, including staff time, legal consultation, and city council or county commissioners' approval. These costs cannot be estimated at this time.

Expenditures by cities, counties, or special purpose districts under this legislation would be equivalent to funds received under the established grants or loans to provide internet access to communities for which access was previously cost-prohibitive. However, it is unknown how much funding would be made available for these grants or loans in the biennial budget, how much funding would be specified for each individual project, nor how many grants or loans would go to cities, how many grants or loans would go to counties, and how many grants or loans would go to special purpose districts.

C. SUMMARY OF REVENUE IMPACTS

Revenue impacts of the legislation on local governments, with the revenue provisions identified by section number, and when appropriate, the detail of revenue sources. Delineated between city, county and special district impacts.

This legislation would have an indeterminate revenue impact on local governments.

The legislation would result in indeterminate revenue for cities, counties and special purpose districts. Cities, counties, and special purpose districts would be eligible to apply for a competitive grant or loan. These funds would also be open to federally recognized Indian tribes. There is no information available to predict whether local governments would receive a grant or loan, nor which jurisdictions. If the award went to local governments, revenue would increase by the grant or loan amount.
