II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

Section 6: The bill prohibits foreign-influenced corporations from making any expenditure, including independent expenditure, or contribution to a political committee or party.

Section 7: The bill requires any for-profit corporation subject to the Business Corporations Act (Title 23B RCW), and any limited liability company formed or required to register under Ch 25.15 RCW, that makes an expenditure or contribution to submit a certification to the Public Disclosure Commission that the entity was not a foreign-influenced corporation as f the date the expenditure or contribution was made. The certification must be submitted within 7 days that the expenditure or contribution was made. The certification must be signed by the corporation's 2chief executive officer. The corporation or LLC must provide a copy of the certification within the 7-day period to the receiving PAC, and any other person upon request of the recipient.

Section 8: The bill repeals the law prohibiting contributions and expenditures made or financed by foreign nationals and requiring all non-individuals making contributions or expenditures to certify the contribution or expenditure is not from a foreign national.

The bill requires certain for-profit corporations and certain limited liability companies to file certifications to the PDC for contributions and expenditures made. PDC has received reports of contributions identifying 100,000 unique entities that were identified by the campaign as likely falling under the requirements of HB 1885. (In the contribution dataset, code is "Business" or "Other" and contributor category is not "Individual"). There were 14,000 and 8,000 unique entities in 2022 and 2023, respectively.

It is anticipated that this provision will require the PDC to develop and produce a new electronic filing system for a class of filers currently are not required to file reports to the PDC for the type of transactions in this bill. The new filing system will be incorporated into the PDC website-based filing system. Based on the requirements of the bill and assumptions from the function of the PDC's existing filing systems, the new filing system must include key requirements, such as: Registration and access through a unique Secure Access Washington (SAW) account; date-specific certification, which will remain valid for a period of time or until the entity changes its status; and review of each new profile created to identify and manage with existing records. The new system will be accessible and searchable by the public on the PDC website and through the open data portal.

The work of developing and producing the new reporting system with the requisite features would be provided internally (without outside procurement), and strategically phased in order to meet the effective date. Additional project staff will be necessary to hire to work along existing staff to complete the implementation. The agency estimates the work, including production and post-launch implementation and maintenance, is estimated to be fully competed within 18 months. This timeframe assumes the PDC will have to adjust current project schedules and priorities, which may be delayed in order to complete this project.
