II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Section 1(1) subject to funds specifically appropriated for this purpose, impacted counties will require registration or voting notices, forms, instructions, assistance and other content related to the electoral process in the language of covered minority language groups as designated by the secretary of state.

Section 1(2) requires the secretary of state to determine which counties need language assistance during elections when more than 2.5 percent of voting-age citizens in certain language minority groups in the county do not speak or understand English adequately enough to participate in the electoral process and have not completed the fifth grade at a rate higher than the national average.

Section 1(6) subject to funds specifically appropriated for this purpose, the secretary of state shall establish a grant program to fund counties that would voluntarily like to provide electoral assistance in a language other than English.

Section 1(2) - Subject to appropriation

Based on our estimates, we believe the following three counties meet the definition of covered counties in Section 1(2): Chelan, Douglas and Grant Counties. The data to make this determination is based on the most current population estimates derived from the American community survey along with relevant decennial census data.

The Secretary of State provides the State Voters' Pamphlet to aid county auditors in improving meaningful access to elections information. Under the provisions of this bill, an additional three Voters' Pamphlet editions would likely be provided as bilingual pamphlets in English and Spanish. In this connection the secretary of state assumes that an average 112,500 voters' pamphlet will be mailed to the three counties. The estimated cost for the composition, printing and distribution, translation and community review of the translated material, for the voters' pamphlet will be \$72,500 per fiscal year.

Section 1(6) – Indeterminate, and subject to appropriation

This section establishes a grant program subject to appropriation to assist counties voluntarily opting to provide elections materials in a language other than English. OSOS has no way of estimating how many counties would opt-in. However, based on the counties subject to Section 1(2) we can assume that it would cost approximately \$73,000 per fiscal year for an additional three counties to opt-in.

Part IV: Analysis A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

Counties must provide language assistance during elections when more than 2.5 percent of voting-age citizens in an Asian-American or Hispanic Language Minority Groups in the county do not speak or understand English adequately enough to participate in the electoral process and have not completed the fifth grade at a rate higher than the national average.

The type of assistance required is defined the same as in federal law.

Additionally, counties must provide language assistance for American Indians or Alaska Natives if the county contains all or part of an Indian reservation, when the American Indians or Alaska Natives meet the requirements listed above.

The Secretary of State (SOS) is responsible for determining which counties are subject to these language assistance provisions. The list of covered counties is determined using the American Community Survey and relevant decennial census data and is updated every five years.

Counties have one year to reach full compliance. A county's status as a covered jurisdiction remains in effect unless terminated by the SOS. County auditors may petition for the SOS to terminate the designation if the LMG no longer meets the criteria for assistance. The SOS must establish a grant program to provide funding to counties that are not covered jurisdictions but choose to voluntarily provide electoral assistance in a language other than English.

The requirements in this act are subject to the availability of amounts appropriated for this specific purpose.

B. SUMMARY OF EXPENDITURE IMPACTS

Expenditure impacts of the legislation on local governments with the expenditure provisions identified by section number and when appropriate, the detail of expenditures. Delineated between city, county and special district impacts.

The potential costs for implementing this bill, including developing bilingual voter instructions and materials, is estimated to be \$714,810 for Fiscal Year 2024. These costs would be incurred by three counties based upon an analysis prepared by the Washington State Association of County Auditors (WSACA). These three counties are Chelan, Douglas and Grant. The costs for succeeding years will likely increase by an indeterminate amount, due to inflation, but are estimated at the Fiscal Year 2024 amount for the purposes of this analysis.

This analysis is based a determination by the Office of the Secretary of State of covered counties based upon current results from the United States Census. It is possible that the number of counties impacted by these provisions could increase or decrease in future years based upon changes in Census results. These changes cannot be predicted with certainty and are indeterminate.

This analysis does not include costs incurred by four counties already voluntarily providing bilingual election instructions and voting materials. It is assumed that these costs are likely similar in scope to estimates provided by the Washington State Association of County Auditors for counties impacted by this legislation, but these costs are not incorporated into the fiscal impacts of this legislation because the counties would not have to alter their current practices.

DISCUSSION:

In addition to four counties that voluntarily provide bilingual election instructions and voting materials, three additional counties would be impacted by this legislation. The cost for each county to comply with these requirements is estimated at \$238,270 per county based upon estimates prepared by the Washington State Association of County Auditors. The total cumulative cost to comply with this legislation is \$714,810 (\$238,270 x 3 = \$714,810).

The total cost consists of the following expenditure assumptions:

- -- \$90,000; one staff person responsible for providing all services in the new language(s), including translating ballots, all voting and outreach materials, providing customer service in-language, coordinating with community partners and working with community media.
- -- \$90,000; one staff person to provide customer service, fill-in when the primary translator is out, providing proofing support and providing overflow support during peak work periods.
- -- \$11,000; temporary staff during high volume (i.e. general) elections
- -- \$9,653; overtime translation on evenings and weekends during peak translation periods.
- -- \$12,066; agile and special duty needs.
- -- \$2,250; advertising for voter education and outreach.
- -- \$9,700; printing, binding and mailing foreign language election materials.
- -- \$6,000; translation services through third party vendors.

C. SUMMARY OF REVENUE IMPACTS

Revenue impacts of the legislation on local governments, with the revenue provisions identified by section number, and when appropriate, the detail of revenue sources. Delineated between city, county and special district impacts.

The legislation requires an adequate appropriation by the Legislature in order for the provisions of this legislation to go into effect. There is no appropriation set at this time so the revenue impact to local governments is indeterminate and will depend upon the amount established by the Legislature through setting of the budget.
