II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

An act relating to modifying the community parenting alternative for eligible participants in the residential parenting program at the Department of Corrections (DOC); and amending RCW 9.94A.6551.

Section 1(1)(b) amends RCW 9.94A.6551 to state that incarcerated individuals not sentenced under RCW9.94A.665, but otherwise eligible under this section who are participating in the residential parenting program, no more than the final 18 months of the incarcerated individual's term of confinement may be served in partial confinement as home detention as part of the parenting program.

Section 1(9)(c) adds new language defining "Residential parenting program" as a correctional nursery program administered by the department that allows pregnant, minimum security incarcerated individuals that meet eligibility criteria established by the department to keep their newborn children with them after giving birth in a designated unit and receive support and education in alliance with skilled early childhood educators.

Effective date is assumed 90 days after adjournment of the session in which this bill is passed.

We assume this bill will have a fiscal impact to Department of Corrections (DOC) more than \$50,000 per Fiscal Year (FY).

Customization of the Offender Management Network Information (OMNI) system is needed to meet the requirements of this legislation. Due to the complexity of completing the development, testing, and implementation of the statutory changes, contracted services are necessary in FY2024.

To implement this legislation, OMNI data tables need to be updated to RCW 9.94A.525 for technical corrections.

Cost Calculation Estimate:

IT Application Developer \$120 per hour 20 hours = \$2,400

IT Quality Assurance \$\\$120 per hour 8 hours = \\$960

IT Business Analyst | \$120 per hour 20 hours = \$2,400

Total One-Time Costs in FY2024 \$5,760

The proposed bill language expands participation to allow incarcerated individuals not sentenced under RCW 9.94A.655 but are eligible for the residential parenting program, may serve partial confinement as home detention for no more than 12 to 18 months of their final term of confinement. This bill would potentially increase caseloads, albeit a minor increase, as the length of stay in the program would be extended by up to 6 months. The DOC assumes this bill would likely result in an Average Daily Population (ADP) increase, although the impact cannot be reliably estimated.

An increase in ADP may increase the need for case management services and would likely result in a need for an additional position describe below to provide the same level of case management that participants receive from the

Residential Parenting Program.

Therefore, there is a determinate cost of \$5,760 for OMNI Updates. Changes in caseload needs may result in an indeterminate fiscal impact, assumed to be more than \$50,000 per FY.
