This bill would prohibit associations of apartment owners from adopting or enforcing any rule, bylaw, or provision prohibiting or unreasonably restricting the installation or use of a heat pump. It would allow apartment owners to file an action to install a heat pump or to compel compliance with this bill, direct the court to award reasonable attorneys' fees and subject associations in violation to a civil penalty of no more than \$1,000.

Part IV: Analysis

A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

This legislation would prohibit common interest communities from adopting restrictions that effectively prohibit or unreasonably restrict the installation or use of heat pumps by unit owners. Unit owners must obtain any permit or approval for a heat pump as required by local law and meet all applicable health and safety standards as required by law. Apartment owners may bring civil action against an apartment owners association for legal costs up to \$1,000 for violations. A definition of “heat pump” and “reasonable restriction” is provided.

Sec. 5 is a new section which provides an expiration date of January 1, 2028 for sections 1 through 3 of this act.

This legislation would take effect 90 days after adjournment of the session in which the bill is passed.
