Section 1(4) requires the Office of the Secretary of State (OSOS) to provide election data to the director of the Washington Election Database, following the certification of elections results and the completion of the voter history file after each general election.

OSOS would provide election data to the Washington Election Database. For purposes of this note OSOS assumes, it would not need to modify or otherwise format the certification of election results and the completion of the voter history file after each general election, to be compatible with any electronic systems at the Washington Election Database. With these assumptions, OSOS could provide the data with minimal impact. However, if the data needs to be modified, we estimate it could take a 0.5 FTE (Data Consultant 3, Range 56 Step L, \$40,000 in salary) to manage and collaborate with the director of the database and database staff in this process. The annual cost of this position would be approximately \$67,000 for compensation, standard goods and services, travel, and agency administrative costs.

Section 1(8) – Potential, But Indeterminate Costs

Section 1(8) specifies that political subdivisions are provided with languages to provide assistance to members of language-minority groups pursuant to Section 203 of the Voting Rights Act. OSOS assumes this means one of the three languages currently required in Washington under Section 203 (Chinese, Spanish, and Vietnamese), rather than the 73 languages possible under Section 203.

The database created in Section 1(1) collects census and population information (Section 1(3)). The federal Voting Rights Act requirements are updated every 5 years by the U.S. Census. OSOS believes this bill could create additional language requirements that would be published January 1, 2025.

The impact of those language determinations could mean that some jurisdictions would be newly required to translate their voting materials into the identified languages. The Office of the Secretary of State matches any federally required language determinations to avoid the potentially significant confusion caused for the voter when receiving their voter pamphlet, for example, in English from the state but in the preferred language from the county. This fiscal impact is indeterminate because OSOS does not have information on how many pamphlets would need to be produced, but we currently produce our language versions at an average cost of \$1.50 per copy, which includes printing, distribution, postage, translation, and composition.

#### II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

Senate Bill 5837 would establish the Washington Election Database at the University of Washington (UW). The purpose of the database is to help the state and political subdivisions evaluate existing election laws and practices, implement best practices, and investigate potential infringements on the right to vote. The database director is required to be employed by the UW and may hire staff necessary to implement and maintain it. The measure contains requirements for the election and demographic records that must be maintained by the database as well as analysis and data staff are required to publish.

The following staff and other resources will be needed for ongoing administration of the Washington Election Database:

Staff:

A principal investigator (salary: \$197,685; benefits rate 22.6%) to coordinate project activities and staff, complete ballot data analyses, engage county election administrators, and produce research reports.

One Ph.D. student research assistant (0.5 FTE; salary: \$57,582; benefits rate: 18.2%) to complete data gathering and analytics work related to the study of rejected and cured ballots, support convenings and engagement with county elections offices and community-based organizations to examine best practices in elections administration and contribute to production of research reports.

One Ph.D. student research assistant (0.5 FTE; salary: \$76,667; benefits rate: 18.2%) to serve as the data master and website manager, managing and processing voter data, ballots data, and census tract data (running the data and software pipeline for integrated data production), securely store and manage data in the data repository, document and manage data cleaning, website maintenance, completion of race imputations, create voter language files, manage and audit the secure data access, as well as provide tailored, user-requested de-identified data files for analytic work, including codebooks, documentation, and coding consultations.

One staff member from the Evans Policy Innovation Collaboration (salary: \$80,544; benefits rate: 30.0%) to analyze rejected ballots data, engage county election office administrators, work with community-based organizations around projects to reduce ballot rejections, and contribute to production of research reports.

A Center for Studies in Demography and Ecology (CSDE) research scientist (salary: \$100,512; benefits rate: 30.0%) to redesign and upgrade the SQL database; designing implementing census tract data integration with vote count and ballot rejection data; updating the PostGIS framework for area-weighted estimates of race and ethnic characteristics applied to voting precinct polygon data, maintain and update code, update and maintain R Markdown based interface for mapping visualizations and downloadable data. Dr. Godwin will also oversee and mentor the CSDE RA for the project, providing guidance on streamlining of data processing and conducting regular audit checks and addressing user access queries. Dr. Godwin will be available for technical and statistical consultations to the team members and data users.

A research administrator (salary: \$91,800; benefits rate: 30.0%) to support project activities and internal grants administration.

A research administrator from CDSE (salary: \$85,800; benefits rate: 30.0%) to support project activities and internal grants administration.

Professional Service Contract:

An outside researcher is expected to receive \$17,573 in consulting fees for coordinating project activities and staff, completing ballot data analyses, engaging county election administrators, and producing research reports.

Goods and Services:

Funding of \$15,000 will support the hardware and software costs associated with storing data in a secure computing environment within CSDE.

Grants, Benefits & Client Services:

As part of their compensation package, tuition expenses are paid for graduate Research Associates at the University of Washington. Funds are therefore requested to pay 6 academic quarters of tuition for the two Ph.D. student research assistants, at a cost of \$35,337.

Overall, the UW expects the costs of administering the Washington Election Database to be approximately \$250,000 per year.

## Part IV: Analysis A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

The proposed legislation would codify the Washington Election Database established in 2022 at the University of Washington as an election database repository.

Sec. 1 would add a new section to chapter 29A.04 RCW.

Sec. 1 (1) would establish the Washington Election Database to assist the state and all political subdivisions with evaluating whether and to what extent laws and practices with respect to voting and elections are consistent with public policy, implementing best practices in voting and elections, and investigating potential infringements upon the right to vot

Sec. 1 (8) would establish that on or before January 1, 2025, the database must publish on its website and transmit for dissemination to county auditors and the Secretary of State a list of political subdivisions required by the federal Voting Rights Act to provide assistance to members of language minority groups and each language in which those political subdivisions are required to provide assistance. Each county auditor would be required to transmit the list to all political subdivisions within their jurisdiction.

Sec. (9) Database staff would be allowed to work with county auditors to examine new practices and solutions for reducing ballot rejections and increasing ballot cure rates.

Sec. (10) Database staff would be allowed to provide nonpartisan technical assistance to political subdivisions, scholars and the general public seeking to use the resources of the database.

#### **B. SUMMARY OF EXPENDITURE IMPACTS**

Expenditure impacts of the legislation on local governments with the expenditure provisions identified by section number and when appropriate, the detail of expenditures. Delineated between city, county and special district impacts.

The proposed legislation's expenditure impact on local governments is indeterminate until additional information is available to determine workload impacts; however, de minimis is anticipated because the legislation would not require county auditors or local governments to make substantive changes.

#### BACKGROUND:

In 2022, the Legislature provided funding to the University of Washington to establish Washington's election data repository to assist the state and all political subdivisions with evaluating whether and to what extent existing laws and practices with respect to voting and elections are consistent with public policy, implementing best practices in voting and elections, and to investigate potential infringements upon the right to vote.

#### PROPOSED LEGISLATION IMPACTS:

The proposed legislation would codify the Washington Election Database. Each county auditor would be required to transmit a list provided by the database to all political subdivisions within their jurisdiction. The amount of time auditors will require to disseminate these lists, the follow-up questions auditors may receive, and the amount of time auditors require to answer the questions is not known at this time. Therefore, the proposed legislation's impact is indeterminate until additional information is available but likely de minimis.
