Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

The substitute legislation allows the Department of Health (DOH) to use an existing data system or systems for mapping opioid deaths and directs DOH to use existing data systems to the extent possible to avoid increasing data reporting requirements or duplication of work. It amends instruction to the Washington State Opioid Overdose Trends Review Committee in section 2 and redirects appropriated funds in section 3.

These changes do not change our assumptions stated in the original version.

The proposed legislation does not create a fiscal impact to the Washington State Patrol (WSP).

New Section 1 requires DOH to create a system or utilize an existing system or systems for mapping reported incidents of fatal and nonfatal drug overdoses and synthetic opiate poisonings in Washington State. It encourages state and local law enforcement agencies to make all data related to incidents of fatal and nonfatal drug overdoses and synthetic opiate poisonings not more than 24 hours after the incident or after receiving the incident toxicology report.

New Section 2 (1) requires the creation of a Washington state opioid overdose trends review committee for the following purposes:

- (a) Identifying and reviewing fatal and nonfatal drug overdoses in the state of Washington;
- (b) identifying the causes and contributing factors of overdoses and overdose-related deaths, and conducting a review of other factors including, but not limited to, housing status, behavioral health status, or criminal justice system involvement;
- (c) Developing recommendations to address preventable overdose-related deaths, including legislation, policies, areas for scientific research, rules, training, and best practices that reduce harm and support the health and safety of individuals who use substances, and prevent overdose-related deaths;
- (d) Providing annual updates on drug trends, including synthetic drugs that may impact the health and well-being of Washingtonians and that present a high risk for causing overdose-related deaths, and making policy-related and funding-related recommendations to the governor and the legislature based on these trends.
- (e) Establishing a process for data sharing between state departments, counties, local health jurisdictions, tribal partners, community overdose prevention groups and other relevant entities in order to access necessary data concerning fatal and nonfatal drug-related overdoses in Washington; and
- (f) Ensuring coordination and integration with the state's opioid overdose response learning community, led by the Health Care Authority.

New Section 2 (2) states that in convening the interested stakeholders pursuant to subsection (1) of this section, the department shall invite a variety of interested stakeholders, including public health experts, physicians, law enforcement, coroners, and persons who have experienced an overdose.

New Section 3 appropriates \$7,000,000 in funding in fiscal year 2025 to the Criminal Justice Training Commission for the purpose of the Washington Association of Sheriffs and Police Chiefs (WASPC) to administer a grant program for multijurisdictional drug task forces.

WSP currently has a procedure in place to record cases of opiate use. Every time a trooper utilizes Naloxone they complete a tracking sheet and assign a case number. It is tracked in the Crime Investigation and Tracking of Evidence (CITE) system. WSP could write a report from the CITE databases cases that indicate Opiate Use (Naloxone). We could provide the report to DOH via email. This would be a simple report that is not expected to create a fiscal impact.

Section 3 states the sum of \$7,000,000, or as much thereof as may be necessary, is appropriated for the fiscal year ending June 30, 2025, from the general fund to the Criminal Justice Training Commission for the purpose of the Washington Association of Sheriffs and Police Chiefs to administer a grant program for multijurisdictional drug task forces. The Washington Association of Sheriffs and Police Chiefs may retain up to five percent of the amounts provided in this section for administration of the program.

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

Section 1: This bill allows the Department of Health (DOH) to utilize an existing data reporting system or create a new one. The previous version directed DOH to create a new system. This change lowers the overall fiscal impact of this bill.

Section 2: This bill adds section 2(3)(a-d); mandating that the department shall submit a report by November 1, 2025, and clarifies the intent of the workgroup created by this bill.

Section 2 requires DOH to convene stakeholders for the purpose of developing recommendations for the establishment of a Washington state opioid overdose trends review committee. The workgroup shall submit a report By November 1, 2025, making recommendations for how a Washington state opioid overdose trends review committee would be established to meet the responsibilities outlined in subsection (1) of this section to the governor and appropriate committees of the legislature. Such report shall take into consideration:

- (a) The determination of what interested stakeholders should be included in any review committee;
- (b) How often the committee should meet on an annual basis;
- (c) Whether the review committee should be encompassed into the structure of the current state opioid response plan as codified in RCW 43.70.770; and
- (d) Any and all costs associated with implementing subsection (1)(a) through (e) of this section.

Section 2(4) mandates the department to establish the committee by September 1, 2026.

Section 1 allows DOH to use an existing system or systems for mapping reported incidents of fatal and nonfatal drug overdoses and synthetic opiate poisoning in Washington state. This decreases the overall fiscal impact to DOH because the department has applicable existing systems to supplement the reporting requirements in this bill.

Section 2 directs DOH to convene stakeholders to develop recommendations for the establishment of a Washington state opioid overdose trends review committee. DOH is assuming that since the committee is mandated, staff capacity to manage the workgroup (WMS3, HSC4, HSC3, and AA) will be on-going. DOH may incur additional fiscal impacts of implementing the committee requirements in Section 2(1)(a-f) beginning in September 2026, subject to the committee's recommendations. DOH requires the following staff and resources to complete this work:

0.20 FTE WMS2 (FY25)

Reviews the CHARS system and vital records data to determine ability to provide required data.

0.30 FTE Epidemiologist 2 (FY25)

Participates in the workgroup on development of the required report providing input and expertise from the Center of Data Sciences.

0.20 FTE Epidemiologist 3 (FY25)

Participates in the workgroup on the development of the required report providing input and expertise from the Center of

Health Statistics.

0.20 FTE WMS3 – Director of Behavioral Health (FY25 and ongoing)

Facilitates work group. Works with Workgroup Coordinator to develop agendas and strategize next steps. Develops partnerships with stakeholders.

1.0 FTE Health Services Consultant 3 (HSC 3) – Opioid and Overdose Review Planning Workgroup Coordinator (FY25 and ongoing)

Coordinates workgroup. Works with stakeholders and internal partners to identify members. Works with Center for Behavioral Health, Prevention and Community Health (PCH), and the Office of Health Sciences (OHS) to discuss and strategize tactics and activities. Works with Office of Behavioral Health (OBH) to invite members to workgroup, schedule meeting, and organize community membership including compensation if needed. Develops agendas with OBH, prepares agendas, attends meetings, takes notes, and handles technology aspects of workgroup meetings. Works with communications team to post agendas and notes to accessible webpage. Works with communications team to send out GovDelivery e-newsletter to members. Assists in report development.

1.0 FTE Health Services Consultant 4 (HSC 4) – Policy Coordinator (FY25 and Ongoing)

Supports the determination of the compilation of the group, ensuring a process for appointment of members, working with Gov's Office on any necessary appointments, setting up the group's decision-making processes, coordinating legal guidance for the committee, in-depth policy research and analysis per the direction of the Committee, development and review of any policy and funding recommendations the Committee makes for the Legislature, ensuring the meetings meet the Open Public Meetings Act and provide a space for public comment. Manages process to engage with Tribes for government-to-government communications and planning. Reaches out to similar workgroups to identify similar goals and overlaps. Engages with state and local agencies as directed by the workgroup. Provides subject matter expertise in opioid and overdose. Works with Workgroup Coordinator to develop activities. Leads report development.

0.30 FTE Administrative Assistant – (FY25 and Ongoing)

Sets up and provides support for virtual meetings. Processes travel, stipends, and procurements. Processes human resources requests. Manages hiring process for HSC3 and HSC4 positions.

Meeting Accessibility: \$3,050 in FY25 and FY26

Translation Services per fiscal year - \$1,500 (rounded) (Materials for 6 meetings in FY25 and 6 in FY26 (total of 12 meetings) translated into top 3 languages; (Spanish: \$78/300 word document; Russian and Vietnamese: \$84/300 word document).

Interpretation Services per fiscal year - \$650 (rounded) for 6 meeting per year (12 meetings total)

- (1h meetings/month x \$105/hour of service).

Communication Access Real-time Translation (CART) Services per fiscal year - \$900 for 6 meetings per year (12 meetings total)

- (1h meetings/month x \$150/hour of service).

Participant Compensation: \$8,100 in FY25 and FY26

In compliance with RCW 43.03.220, Compensation of Members of Part-Time Boards and Commissions – Class one groups, this bill would require compensation of community members with lived experience and/or those living in poverty. All community engagement activities at DOH must be in compliance with Title II of the Americans with Disabilities Act, the Heal Act Community Engagement Guide, and possibly the Open Public Meeting Act. In addition to the cost of compensation, observance of these statutory obligations includes providing reimbursement for travel, lodging, and dependent care; translation and interpretation services for all meetings and materials; and the staffing to support managing resources and associated program activities.

- Ten participants in 6- one-hour meetings/year (total of 12 meetings) and performing 1h/month of additional work time outside of group (12h/year total per participant with a total of 24h) at \$45/hour.

A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

CHANGES BETWEEN THIS VERSION AND PREVIOUS BILL VERSION:

There were no changes made between versions that would change the impact of the bill on local government.

SUMMARY OF CURRENT BILL:

Sec. 1 (Adds new section to RCW 43.70):

The department shall work with emergency medical service providers, emergency departments, state and local law enforcement agencies, sheriffs' offices, and coroners to create a system for mapping reported incidents of fatal and nonfatal drug overdoses and synthetic opiate poisonings in Washington state.

Sec. 2 (Adds new section to RCW 43.70):

(2) In convening the interested stakeholders, the Department of Health (DOH) must invite public health experts, physicians, law enforcement, coroners, and persons who have experienced an overdose.

Sec. 3 (New Section)

Directs the transfer of a sum of \$7 million, or as much thereof as may be necessary, from the general fund of to the Washington State Association of Sheriffs and Police Chiefs (WASPC) for the fiscal year ending June 30, 2025. The transferred funds are to be use to administer a grant program for multijurisdictional drug task forces. WASPC must require recipients to adhere to the same peer review and reporting requirements that existed for recipients of the Edward Byrne memorial justice assistance grant fund.

B. SUMMARY OF EXPENDITURE IMPACTS

Expenditure impacts of the legislation on local governments with the expenditure provisions identified by section number and when appropriate, the detail of expenditures. Delineated between city, county and special district impacts.

CHANGES IN EXPENDITURE IMPACTS BETWEEN THIS VERSION AND PREVIOUS BILL VERSION:

There were no changes made between versions that would change the impact of the bill on local government expenditures.

EXPENDITURE IMPACTS OF CURRENT BILL:

This legislation would have an indeterminate expenditure impact on local governments.

There is no available data which could be used to estimate the cost of applying for the grant program. Additionally, there is no available data which could be used to estimate the cost of adhering to the peer review and reporting requirements.

The cost of reporting all incidents of fatal and nonfatal drug overdoses and synthetic opiate poisonings is indeterminate but is estimated by WASPC to be significant given Washington state's high number of overdoses.

This legislation would have an indeterminate revenue impact on local governments.

The amount awarded to local government through this grant program is indeterminate because the amount to be awarded has not been specified and the total amount transfer to WASPC has not been finalized.
