To implement this bill, OSPI assumes the following:

0.01 FTE of an Administrative Assistant's time will be needed to update branding on current curriculum, presentations materials, and the OSPI website to reflect John McCoy (lulilaš) Since Time Immemorial. OSPI estimates the cost to be \$2,000 in FY25.

The Office of Native Education staff will need to have a Lushootseed keyboard installed on their current computers to support the Lushootseed language, a Central Coast Salish language of the Salishan language family. The program is free to download and will require minimal staff time of OSPI's Information Technology Support program to install.

The Office of Native Education staff will collaborate with OSPI's Communications program to develop an audio recording to properly articulate the native name of John McCoy. OSPI assumes this will require minimal staff time.
