Section 1 of the bill requires the Criminal Justice Training Commission (CJTC) to develop and administer training in evidence-based, noncoercive interrogation techniques for law enforcement personnel.

The Gambling Commission conducts custodial interviews on average once a month and will need to ensure agents attend the updated training provided by CJTC. Because CJTC is providing the training free of cost, there is no fiscal impact to the agency.

Subject to the availability of amounts appropriated for this specific purpose, the commission shall contract with an expert or organization with expertise in interrogation tactics to develop, administer, and periodically revise a training in evidence-based, noncoercive interrogation techniques for law enforcement personnel.

Any law enforcement agency may contract for or otherwise receive training in evidence-based, noncoercive interrogation techniques from entities other than or in addition to the commission or the commission's contracted expert or organization, provided that any entity that the law enforcement agency contracts with or otherwise receives such training from must be certified in the techniques described under subsection (2) of this section.

CHANGES MADE BY THE SECOND SUBSTITUTE:

Eliminates all provisions in the bill related to establishing a presumption of inadmissibility for certain confessions made during a custodial interrogation in response to the interrogating officer's use of deception.

Adds a null and void clause, making the bill null and void unless funded in the budget.

The proposed second substitute legislation eliminates the fiscal impacts to the Washington State Patrol (WSP).

The proposed second substitute legislation removes the sections that defined “custodial interrogation” and “deception” as well as the exemptions to these definitions. It also removed the section that would make a statement inadmissible if the court determined that the officer intentionally engaged in deception in obtaining the statement as well as the section that would allow the prosecution to overcome the presumption of inadmissibility if it proves that the person’s statement was voluntary.

New Section 1 requires the CJTC, subject to the availability of funding appropriated for the purpose, to contract with an expert or organization with certain expertise to develop, administer, and periodically revise a training in evidence-based, noncoercive interrogation techniques for law enforcement personnel, and to begin offering the training by July 1, 2025, at no cost to law enforcement personnel or agencies. It also allows any law enforcement agency to contract for or otherwise receive training in evidence-based, noncoercive interrogation techniques, provided that any entity that the law enforcement agency contracts with or otherwise receives such training from must be certified in the techniques described under subsection(2).

New Section 2 states that if specific funding is not provided by June 30, 2024, this act is null and void.

1062 2S HB differs from 1062 S HB in the following ways:

Section 1 and Section 2 from 1062 S HB are removed from the bill language thus eliminating all provisions in the bill related to establishing a presumption of inadmissibility for certain confessions made during a custodial interrogation in response to the interrogating officer's use of deception.

Second Substitute House Bill 1062 concerns custodial interrogations by law enforcement. Compared with previous versions, the second substitute removes the presumption that statements made during custodial interrogations are inadmissible in court if it is found that a law enforcement officer intentionally engaged in deception to obtain the statement. Meanwhile, Section 1 directs the Criminal Justice Training Commission to contract to develop, administer, and periodically revise a training in evidence-based, noncoercive interrogation techniques for law enforcement agencies and personnel. This training is required to be offered at no costs starting July 1, 2025.

Second Substitute HB 1062 takes out sections 1-2 and 4-5 of Substitute HB 1062 and adds any law enforcement agency can contract for or otherwise receive training in evidence-based, noncoercive interrogation techniques from entities other than or in addition to the commission, the commission's contracted expert or organization. Also, adds if specific funding for the purposes of this act isn't provided by June 30, 2024, this act will be null and void.

Summary from 1062 Substitute HB:

1062 SHB is the proposed substitute for 1062 HB. 1062 SHB expands the definition of "custodial interrogation" and provides officers exceptions to "deception" tactics. 1062 SHB adds a new section to chapter 43.101 RCW: Dependent upon appropriated amounts the commission will develop, administer, and periodically revise a training in evidence-based, noncoercive interrogation techniques for law enforcement personnel. Also, adds an effective date for the proposed bill of December 1, 2025.

The current model for interrogation training is determined to be coercive and as such, switching to a non-coercive model will require officer training either by a third party, which the bill allows in section 1(5), or by the commission or its contracted expert/organization.

Because officers will need to be trained immediately upon the passage of this bill, CWU would choose to have officers trained by a third party. For the critical task of interviewing, CWU believes in-person training is the best choice for learning and retention of the material and would choose a third-party in-person training option over a CJTC virtual training option.

The costs identified in this request are a third-party per-person training cost and the per-diem rates for the Seattle area. If the legislature intends to ensure all officers comply with the law upon being signed, then CWU would need to engage with a third-party trainer to ensure adequate training outcomes for our officers, which would cost an estimated total of \$22,862 for

14 officers.

3rd party, in-person, and intensive training:

Tuition to 3rd Party Training = \$700/officer x 14 Officers = \$9,800

Per Diem rate for Seattle area for a 3-day course = \$79/day for food and \$232/day for hotel= \$933/officer x 14 officers = \$13,062

2S HB 1062 relates to the use of deception by law enforcement officers during custodial interrogations.

The definitions in section 1 of the previous version of the bill have been deleted.

Section 1(5) includes a new provision that a law enforcement agency may contract for or otherwise receive training in evidence-based, noncoercive interrogation techniques from other than the commission or the commission's experts if the provider of the training is certified in the techniques identified in section 1(2)(a-d).

As the training described in section 1(5) could still be obtained from the Criminal Justice Training Commission at no cost, there is no fiscal impact to the college from this latest version of the bill.

S HB 1062 relates to the use of deception by law enforcement officers during custodial interrogations.

New section 3 adds a requirement for the Criminal Justice Training Commission.

The revised bill creates no additional requirements for the college so the assessment of no fiscal impact is not changed.

This new substitute bill removes all of the original bill's language and replaces it with a mandate for the Washington Criminal Justice Training Commission (CJTC) to contract with experts in interrogation techniques and develop training for all Washington Law Enforcement Officers. This bill, if enacted, would allow for the CJTC to provide a training course in interrogation techniques to law enforcement. DNR officers would take this course if offered by CJTC. A. SUMMARY OF BILL

CHANGES BETWEEN THIS VERSION AND PRIOR VERSION OF THE BILL:

The second substitute requires the Criminal Justice Training Commission to contract with an expert or organization with expertise in interrogation tactics to develop, administer, and periodically revise a training in evidence-based, noncoercive interrogation techniques for law enforcement personnel. It omits the provisions in the previous version that made statements inadmissible as evidence if an officer intentionally engaged in deception. These changes remove the fiscal impact for local governments.

SUMMARY OF BILL:

Sec. 1 adds a new section to RCW 43.101. Subject to the availability of amounts appropriated, the Criminal Justice Training Commission (CJTC) shall contract with an expert or organization with expertise in interrogation tactics to develop, administer, and periodically revise a training in evidence-based, noncoercive interrogation techniques for law enforcement personnel. After development of the training is completed, the CJTC shall make the training available at no cost to all law enforcement personnel and law enforcement agencies in the state.

The CJTC shall begin offering the training by July 1, 2025. Any law enforcement agency may contract for or otherwise receive training in evidence-based, noncoercive interrogation techniques from entities other than or in addition to the CJTC or the CJTC's contracted expert or organization, provided that any entity that the law enforcement agency contracts with or otherwise receives such training from must be certified in the techniques described under subsection (2) of this section.
