II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

1. The Attorney General's Office (AGO) Criminal Justice Division (CRJ) has reviewed this bill and determined it will not increase or decrease the division's workload in representing Washington State Patrol (WSP). Therefore, no costs are included in this request.
2. The AGO Government Compliance & Enforcement Division (GCE) has reviewed this bill and determined it will not increase or decrease the division's workload in representing WSP. GCE provides program-specific advice and litigation support for the WSP. HB 1132 would prohibit bulk delivery of firearms or ammunition. Dealers would be prohibited from delivering more than one firearm or more than a specified number of rounds of ammunition to a purchaser or transferee within a 30-day period. The bill would exempt certain specifically identified recipients, including general authority law enforcement agencies and peace officers. Although GCE provides advice and litigation support to WSP for specific programs, none of those programs would be implicated by the provisions of this bill. Therefore, no costs are included in this request.
3. The AGO Licensing & Administrative Law Division (LAL) has reviewed this bill and determined it will not increase or decrease the division's workload in representing the Department of Licensing (DOL). This bill does not impose any new responsibilities on DOL, and DOL does not inspect or regulate these sales or records. Therefore, no costs are included in this request.

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

The substitute version of the proposed legislation does not have a fiscal impact to the Washington State Patrol (WSP).

This version changes the amended RCW in section 1 from 7.80.120 to 9.41.110.

The proposed legislation would limit bulk purchases and transfers of firearms and ammunition.

Section 1(16) states no dealer may deliver firearms or ammunition in excess of the limits established in section 2 of this act.

New Section 2 adds language to RCW 9.41, regarding purchases of multiple firearms and ammunition within a 30-day period.

New Section 2(3) states that compliance with this section is a condition of dealer licensure and a violation is punishable by forfeiture of the dealer's license.

New Section 3 states if any provision of this act is held invalid, the remainder of the act is not affected.

Changes from HB 1132 to SHB 1132:

Removes civil infraction and criminal penalties

Prohibits firearm dealers from delivering firearms or ammunition above established limits and makes violation punishable by license forfeiture

Provides exceptions to the firearms and ammunition delivery requirements

No change in fiscal impact from previous fiscal note.

NEW DESCRIPTION:

This substitute bill prohibits firearms dealers from being able to sell a certain number of firearms or amount of ammunition to one purchaser or transferee within a 30-day period, with exemptions, and provides new civil infraction penalties.

There are no fiscal impacts on Department of Licensing. We do not regulate firearms dealers or enforce penalties or fines.

Part IV: Analysis

A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

CHANGES BETWEEN THIS VERSION AND PRIOR VERSION OF THE BILL:

The substitute removes the criminal penalties in the original version of the bill, and as such eliminates the local government impact.

SUMMARY OF THE BILL:

Sec. 1 amends RCW 9.41.110. No dealer may deliver firearms or ammunition in excess of the limits established in section 2 of this act.

Sec. 2 adds a new section to RCW 9.41 RCW. A dealer may not deliver more than one firearm to a purchaser or transferee within any 30-day period. A dealer may not deliver more than 100 rounds of .50 caliber ammunition or more than 1,000 rounds of any other caliber of ammunition to a purchaser or transferee within any 30-day period. Exceptions are noted in the bill language. Compliance with this section is a condition of dealer licensure under RCW 9.41.110. A violation of this section is punishable by forfeiture of the dealer's license.
