## **Part IV: Analysis**

### **A. SUMMARY OF BILL**

#### **CHANGES BETWEEN THIS VERSION AND PRIOR VERSION OF THE BILL:**

The engrossed second substitute includes technical changes that do not create fiscal impacts for local governments.

#### **SUMMARY OF CURRENT BILL:**

Sec. 2 amends RCW 2.43.020. "Credentialed interpreter" means an interpreter who is credentialed by the Administrative Office of the Courts in a spoken language. This section also defines "judicial officer," "language access plan," "person with limited English proficiency" and "presiding officer."

Sec. 3 amends RCW 2.43.030. Credentialed interpreters shall be appointed in legal proceedings involving participation of persons with limited English proficiency, unless good cause is found on the record for appointing a noncredentialed interpreter.

Sec. 7 adds a new section to RCW 2.43. The court shall appoint a team of interpreters as required by Supreme Court rule.

Sec. 10 amends RCW 2.43.090. Beginning January 1, 2026, and every two years thereafter, all courts must submit their most recent language access plan to the Administrative Office of the Courts.

### **B. SUMMARY OF EXPENDITURE IMPACTS**
