COMPARISON OF THE BILL AS PASSED BY THE LEGISLATURE WITH THE SECOND SUBSTITUTE:
The bill, as passed by the legislature, changes certain liquor license fees.

CURRENT LAW:
The Liquor and Cannabis Board (LCB) issues various licenses, permits, and endorsements for liquor-related activities and determines the fee amount for each.

PROPOSAL:
LCB must increase most fees for liquor licenses, permits, or endorsements.

EFFECTIVE DATE:
The bill takes effect 90 days after the final adjournment of the session.

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

This bill increases the majority of liquor license fees, endorsements, and permits by 50% and selected fees by fixed amounts.

CHANGES MADE BY THE AMENDMENT TO 5786 2SSB:

EFFECT:

Increases the fee for the combination spirits, beer, and wine license in RCW 66.24.035 from \$316 to \$2,000 per year, rather than from \$316 to \$474.

Increases the fee for the grocery store liquor license in RCW 66.24.360 from \$150 to \$550 per year, rather than from \$150 to \$975.

Increases the liquor license fee for restaurants with less than 50 percent of a dedicated dining area in RCW 66.24.420 from \$2,000 to \$2,700 per year, rather than from \$2,000 to \$2,500 per year.

Increases the liquor license fee for restaurants with 50 percent or more of a dedicated dining area in RCW 66.24.420 from \$1,600 to \$2,200 per year, rather than from \$1,600 to \$2,000 per year.

Increases the liquor license fee for service bars in RCW 66.24.420 from \$1,000 to \$1,400 per year, rather than from \$1,000 to \$1,250 per year.

Increases the fee for the spirits retailer license in RCW 66.24.630 from \$166 to \$550 per year, rather than from \$166 to \$249.

Increases the fee for the banquet permit in RCW 66.20.010 from \$10 to \$25, rather than from \$10 to \$15.

The Washington State Liquor and Cannabis Board ("Board") is currently in the middle of a project to upgrade the agency's

internal licensing and enforcement systems. The Licensing, Enforcement, Education, and Administrative Data Systems (LEEADS) is expected to go live in FY 2025. There are change request costs associated with this legislation that will have to be submitted to the vendor or contracted out by the LCB. The estimated costs for these change requests is \$164,486 in FY26. Some examples of changes needed follow:

Vendor cost to implement: \$70,482
Developer: 224.5 hrs x \$392/hr = \$88,004
Business Analyst: 40 hrs x \$150/hr = \$6,000
