This bill identifies stem cell research as something that can create great benefits for illnesses that impact citizens and recognizes that many research companies are in Washington state. It prohibits cloning of human beings. The bill requires the Department of Health (DOH) to create guidelines for stem cell research by January 2006. DOH must also report annually to the legislature on stem cell research activity. The bill also creates a stem cell research advisory committee supported by DOH.

Sections 4 through 6 of this bill expire on January 1, 2008.

The legal services needed to support DOH and the advisory committee will be 0.30 Attorney FTE for the first two fiscal years to help establish the committee and address the legal issues that usually accompany the startup of a new board or commission, including assisting DOH in creating the stem cell research guidelines, rule-making, answering questions related to process and procedures and scope of department and committee authority. Once the startup issues have been addressed continuing support of 0.15 AAG FTE will be needed to provide advice and other legal representation for the committee.

Adding a new chapter in Title 70 RCW to permit stem cell research to

- \*Direct DOH to develop guidelines for stem cell research by January 1, 2006
- \*Direct DOH to review IRB reports (expiring by January 1, 2008)
- \*Direct DOH report to legislature annually (expiring by January 1, 2008)
- \*Direct DOH to establish and maintain an anonymous registry of embryos that are available for research
- \*Establish a human stem cell research advisory committee (expiring by January 1, 2008)

#### Section 4:

This bill requires DOH to develop guidelines for stem cell research. For the purpose of this fiscal note, DOH is assuming they would contract with the University of Washington Health Policy and Analysis Program to develop these guidelines. The contract amount is estimated at \$94,500 in FY05 and \$47,250 in FY06. (Assuming work begins July 2004 and runs through January 1, 2006).

#### Section 4 & 7:

This bill also requires DOH to reveiw IRB reports, report to the legislature annually, and to establish and maintain an anonymous registry of embryos that are available for research. To conduct these activities, DOH would require 1.5 FTEs: 1.0 FTE Health Services Consultant 4 and 0.5 FTE Secretary Administrative. Expenditures for these staff would include salary, benefits, supplies, communication costs, computers, rent, office furniture, and travel. Funds for printing reports and postage would also be required.

In addition, these staff would organize meetings of the human stem cell research advisory committee (13 members, to be appointed by the secretary of health). Costs for an estimated 4 meetings per year would include meeting room rental, light refreshments/lunch, and travel reimbursement for committee members.

After consultation with the Attorney Generals Office (AG), DOH would need to consult with the AG to help establish the advisory committee and address the legal issues that usually accompany the startup of a new board or commission, including creating the stem cell research guidelines, rule-making, answering questions related to process and procedures and scope of department and committee authority. Once the startup issues have been addressed continuing support will be needed to provide advice and other legal representation for the committee.

Increased administrative workload with this legislation will require additional staff in FY05. The increased staff needed will include a .30 FTE Financial Analyst 3 (FA3) in FY05 - 06, .20 FTE FA3 in FY07, and .10 FTE FA3 in FY08.

The bill states that DOH may develop new rules, but does not require them. To properly implement the bill, particularly regarding compiling IRB reports and establishing an embryo registry, new rules would need to be developed to specify: \*Who must submit IRB reports (public and privately funded stem cell researchers), what information should be reported, as well as how to submit the information.

\*Who must report availability of embryos for research, and how to report the information.
